

RESOLUTION NO. 4440

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A CONTRACT FOR CONCRETE LIFTING AND STABILIZATION SERVICES FROM NORTEX CONCRETE LIFT AND STABILIZATION INC. OF FORT WORTH, TEXAS THROUGH AN INTERLOCAL AGREEMENT WITH THE CITY OF GRAND PRAIRIE, TEXAS, DATED OCTOBER 7, 2008, FOR THE PUBLIC WORKS DEPARTMENT, IN THE AMOUNT OF \$100,000, WITH THE OPTION TO EXTEND THE CONTRACT FOR FOUR (4) ADDITIONAL ONE-YEAR RENEWALS, NOT TO EXCEED A PERIOD OF FIVE (5) YEARS, AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to repair concrete pavements in the most efficient and economical way; and

WHEREAS, the General Fund Public Works Department budget provides for the repair of failing street infrastructure; and

WHEREAS, the City of Keller has entered into an Interlocal Agreement with the City of Grand Prairie, Texas, with the adoption of Resolution No. 2741, dated October 7, 2008 allowing the two cities to utilize contracts entered into by each other relative to governmental functions and services, pursuant to the authority granted by Article 791 et seq. of the Interlocal Cooperation Act, Texas Government Code; and

WHEREAS, the City of Grand Prairie has competitively bid for Concrete Lift and Stabilization services and Nortex Concrete Lift and Stabilization, Inc. is the low bidder; and

WHEREAS, the City of Keller is authorized to use the same unit prices submitted by Nortex Concrete Lift and Stabilization, Inc. for Concrete Lift and Stabilization services; and

WHEREAS, the proposed agreement shall last one (1) year with the option to extend said agreement for an additional four (4) one (1) year periods; and

WHEREAS, the Fiscal year 2022 budget provides funding for this work; and

WHEREAS, funding for additional one (1) year periods is contingent upon budget approval by the City Council for street maintenance activities.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, City Council of the City of Keller, Texas, hereby approves the purchase for concrete lifting and stabilization services with Nortex Concrete Lift and Stabilization Inc. of Fort Worth, Texas, through the Interlocal Agreement with the City of Grand Prairie, Texas, dated October 7, 2008 in an amount of \$100,000, and authorizing the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of the Concrete Lift and Stabilization services shall be paid from the Public Works Department, General Fund, budgeted therefor.

AND IT IS SO RESOLVED.
