Introduction

We respectfully submit this proposal to the City of Keller for consideration of a capacity increase at our residential assisted living facility, from the current six (6) beds to eight (8) beds. Request

An increase to 8 beds allows us to responsibly and sustainably accommodate more residents who prefer a more intimate care setting over large institutional environments.

Our facility is located in a residential neighborhood and operates discreetly, maintaining harmony with the surrounding community. Increasing from 6 to 8 residents would not significantly alter the character, traffic, or environmental footprint of our operations. Staffing adjustments and services will remain within manageable limits, ensuring continued compliance with local and state regulations.

4. Promoting Aging in Place

A higher bed capacity supports the aging-in-place model by allowing residents to stay longer in a familiar environment as their needs increase, without having to transfer to larger facilities. This minimizes disruption, supports mental well-being, and leads to better overall health outcomes.

We remain committed to meeting all regulatory requirements including fire safety, health codes, staffing ratios, and space standards as mandated by the Texas Health and Human Services Commission and the City of Keller.
