## RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING AN AMENDMENT TO THE INTERLOCAL AGREEMENT WITH THE CITIES OF SOUTHLAKE, COLLEYVILLE, ROANOKE, THE TOWN OF TROPHY CLUB, AND ADDING THE TOWN OF NORTHLAKE FOR THE PURPOSE OF OPERATING A JOINTLY CONTROLLED NORTH TARRANT REGIONAL SPECIAL WEAPONS AND TACTICS (SWAT) TEAM; AND AUTHORIZING THE CITY MANAGER TO EXECUTE SAID AGREEMENT ON BEHALF OF THE CITY OF KELLER, TEXAS.

- WHEREAS, the City of Keller, Texas, has previously entered into an Interlocal Agreement with the Cities of Southlake, Colleyville, Roanoke, and the Town of Trophy Club for the operation of the North Tarrant Regional Special Weapons and Tactics (SWAT) Team; and
- WHEREAS, the participating agencies have determined that adding the Town of Northlake as a full member will strengthen regional coordination and enhance tactical response capabilities across all jurisdictions; and
- WHEREAS, Chapter 791 of the Texas Government Code authorizes local governments to enter into interlocal agreements for governmental functions and services, including law enforcement support; and
- WHEREAS, the current Interlocal Agreement requires that any amendment be approved by the governing body of each participating entity; and
- WHEREAS, the City Council of the City of Keller, Texas, finds it to be in the best interest of the citizens to approve the Amended and Restated Interlocal Agreement adding the Town of Northlake as a participating agency.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves the Amended and Restated North Tarrant Regional SWAT Interlocal Agreement with the Cities of Southlake, Colleyville, Roanoke, the Town of Trophy Club, and adding the Town of Northlake; and further authorizes the City Manager to execute said agreement on behalf of the City of Keller, Texas.
- Section 3: THAT, this Resolution shall take effect immediately upon its passage.
