A. CALL TO ORDER – Mayor Armin R. Mizani

Mayor Armin R. Mizani called the meeting to order at 5:18 P.M.

Chris Whatley - 3,627 votes (58.88%)

City Council Place 6

Zane Kupper - 2,269 votes (37.03%)
Charles Randklev - 3,858 votes (62.97%)

Elda Rata - 1,183 votes (19.22%)
Russ Medeiros - 2,566 votes (41.69%)
Jarrett Armstrong - 2,406 votes (39.09%)

As no candidate received a majority of the votes cast, a Runoff Election shall be called by the City Council.
