AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING CERTAIN AMENDMENTS TO THE FISCAL YEAR 2023-24 ANNUAL OPERATING BUDGET FOR THE CITY OF KELLER, TEXAS, IN ACCORDANCE WITH ARTICLE VIII, SECTION 8.13, OF THE KELLER CITY CHARTER.

- WHEREAS, the annual budget for the City of Keller, Texas, was adopted by Ordinance No. 2139, by the City Council, dated September 19, 2023, in accordance with the Keller City Charter; and
- WHEREAS, additional expenditures from various funds are proposed for consideration by the Mayor and City Council; and
- WHEREAS, notice of a public hearing before the City Council of the City of Keller, Texas, was published in a newspaper of general circulation in the City of Keller at least ten (10) days before such hearing, in accordance with Article VIII, Section 8.13 of the Keller City Charter; and
- WHEREAS, said notice of public hearing was published in the *Fort Worth Star-Telegram* on Sunday, August 26, 2024; and
- WHEREAS it is proposed that the 2023-24 Annual Budget be amended in accordance with the Keller City Charter.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves certain amendments to the Fiscal Year 2023-24 Annual Operating Budget and the Fiscal Year 2023-24 Capital Improvements Program, in accordance with Article VIII, Section 8.13, of the Keller City Charter.
- Section 3: THAT, the additional sums specified below are hereby proposed to be appropriated from the respective funds on behalf of the City of Keller, Texas:

General Fund (100) amendments (Total Increase \$ -):

\$375,000 – To be transferred to the Keller Self Insurance Fund based upon available salary savings at the end of the fiscal year.

Keller Development Corporation (110) amendments (Total Increase \$,620,616):

\$1,620,616 - Increase in expenditures related to a transfer to Parks CIP for the Sports Park Revitalization Project.

Keller Self Insurance Fund (129) amendments (Total Increase Up To \$600,000):

\$600,000 – Increase in revenue related to a transfer-in from the General Fund and Water-Wastewater Utility Fund based upon available actual salary savings at the end of the fiscal year.

<u>Parks Capital Improvement Fund (178) amendments (Total Increase \$2,620,616):</u>

\$1,620,616 - Increase in revenue transfer-ins from the KDC fund.

\$1,000,000 – Increase in revenue related to debt issuance

\$2,620,616 - Increase in expenditures related to the Sports Park Revitalization Project.

Water-Wastewater Utility Fund (200) amendments (Total Increase \$ -):

\$225,000 – To be transferred to the Keller Self Insurance Fund based upon available salary savings at the end of the fiscal year.

<u>Drainage Utility Fund (400) amendment (Total Increase \$49,000):</u> Increase in expenditures related to MS4 Permit consulting services.

- Section 4: THAT, the additional sums provided in Section 3 above are hereby authorized from existing funds available within the respective fund or thru an approved transfer of funds to the respective fund as stated in Section 3.
- Section 5: THAT, should any part, portion, section, or part of a section of this Ordinance be declared invalid, or inoperative, or void for any reason by a court of competent jurisdiction, such decision, opinion, or judgment shall in no way affect the remaining provisions, parts, sections, or parts of sections of this Ordinance, which provisions shall be, remain, and continue to be in full force and effect.
- Section 6: THAT, all ordinances and appropriations for which provisions have heretofore been made are hereby expressly repealed if in conflict with the provisions of this Ordinance.
