

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A JOINT ELECTION AGREEMENT AND CONTRACT FOR ELECTION SERVICES WITH THE TARRANT COUNTY ELECTIONS ADMINISTRATOR TO CONDUCT THE CITY OF KELLER GENERAL ELECTION FOR THE PURPOSE OF ELECTING THE MAYOR AND CITY COUNCIL PLACES 5 AND 6, AND TO CONDUCT A SPECIAL ELECTION FOR THE PURPOSE OF ELECTING CITY COUNCIL PLACE 4 TO FILL AN UNEXPIRED TERM, TO BE HELD ON SATURDAY, MAY 2, 2026; AND AUTHORIZING THE MAYOR TO EXECUTE SAID AGREEMENT AND CONTRACT ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, on Saturday, May 2, 2026, the City of Keller will conduct a General Election for the purpose of electing the Mayor and City Council Places 5 and 6, and a Special Election for the purpose of electing City Council Place 4 to fill an unexpired term; and

WHEREAS, it is desirable for voter convenience and to reduce the overall cost to each entity that said elections be held jointly on Saturday, May 2, 2026; and

WHEREAS, the City Council of the City of Keller, Texas desires to select the Tarrant County Elections Administrator to conduct and coordinate the City's General and Special Elections.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves a Joint Election Agreement and Contract for Election Services with the Tarrant County Elections Administrator to conduct the City of Keller General Election for the purpose of electing the Mayor and City Council Places 5 and 6, and to conduct a Special Election for the purpose of electing City Council Place 4 to fill an unexpired term, to be held on Saturday, May 2, 2026, in accordance with the terms and conditions set forth in said Agreement and Contract, attached hereto as Exhibit "A".

Section 3: THAT, the Mayor is hereby authorized to execute said Agreement and Contract with the Tarrant County Elections Administrator on behalf of the City of Keller, Texas.
