RESOLUTION NO. 4435

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A PROFESSIONAL SERVICES AGREEMENT FOR THE DESIGN, SURVEY, CONSTRUCTION ADMINISTRATION AND ENVIRONMENTAL SERVICES OF THE BARBARA LANE HIKE AND BIKE TRAIL IMPROVEMENTS, IN THE AMOUNT OF \$63,426.00, WITH PACHECO KOCH CONSULTING ENGINEERS, INC., OF FORT WORTH, TEXAS, FOR THE PARKS AND RECREATION DEPARTMENT; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to add .15 miles of a 10' wide concrete trail between Barbara Lane and the Big Bear Creek Greenbelt Trail to meet the needs of the citizens; and

WHEREAS, the Fiscal Year 2021-22 Keller Development Corporation Fund budget includes funding for the Hike and Bike Trail System Expansion in the amount of \$302,500.00; and

WHEREAS, the city staff recommends selecting Pacheco Koch Consulting Engineers, Inc., for the design, survey, construction administration and environmental services of the project in the amount of \$63,426.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves an agreement for Professional Services for the Barbara Lane Hike and Bike Trail Improvements with Pacheco Koch Consulting Engineers, Inc., of Fort Worth Texas; in the amount of \$63,426.00, for the Parks and Recreation Department, and further authorizes the City Manager to execute all contract documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said services shall be paid from the Parks Capital Improvement Project Fund, with funding provided by the Keller Development Corporation Fund, in the amount of \$63,426.00.
