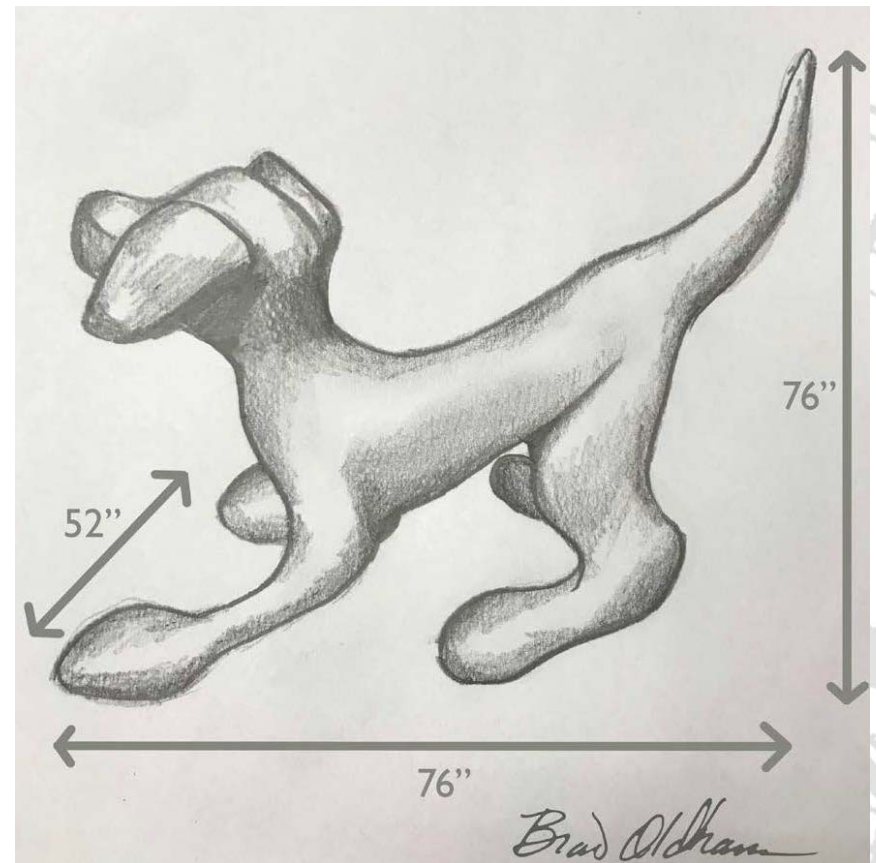
- Public Arts Master Plan (updated 2016) lists installation of an animal-themed sculpture at the Regional Police/Jail/Animal Services facility as a short term project goal
- In 2018, the Public Arts Board invited four (4) artists to submit proposals for design and installation of an outdoor sculpture that would enhance the aesthetics of the space and help increase awareness of the animal adoption services offered within the facility by the Humane Society of North Texas

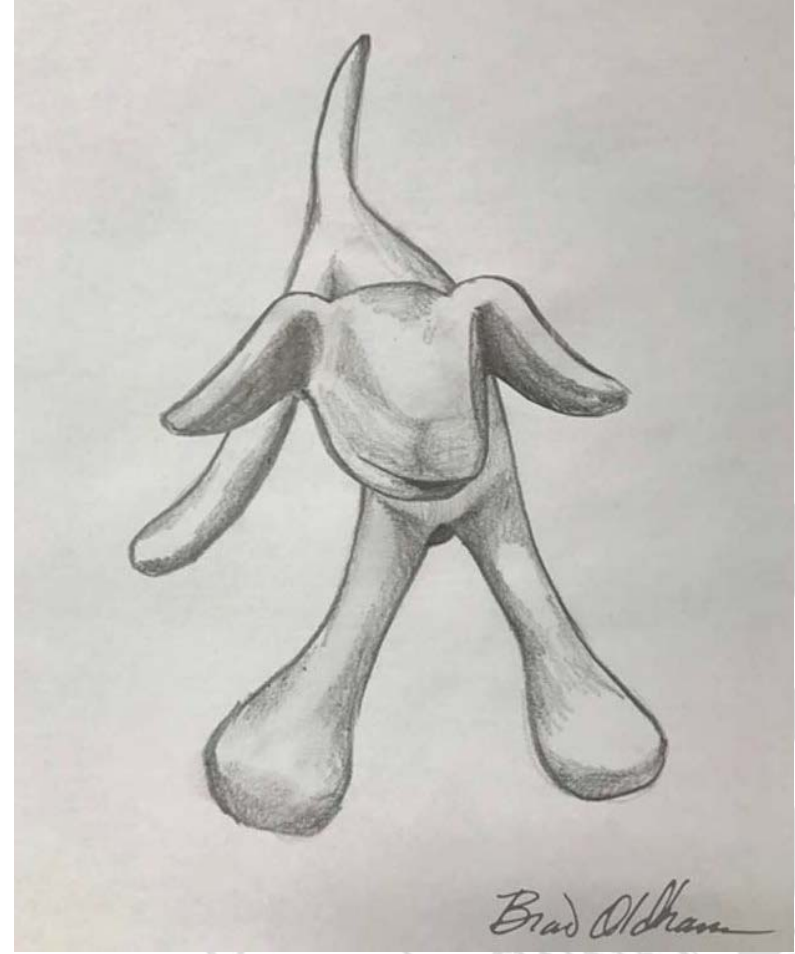
- The proposed agreement is for \$40,000, to include the design, sculpting, fabrication and installation of a 316 polished stainless steel dog sculpture
- The sculpture will be between sixty (60") and eighty-four (84") tall
- Estimated installation date will be late 2019



Item H-6 Budget Information

- Total cost of the sculpture is \$40,000 and includes a small-scale model (maquette)
- Funding is available in the Public Arts Development Fee Fund, created in FY 2015-16 for capturing a 0.25% fee applied to the construction value of new commercial/industrial developments as well as certain residential and commercial expansion projects
- Following City Council approval of the proposed agreement, staff will work with a contractor for design and construction of a sculpture pad, landscaping and lighting

Item H-6 About the artist

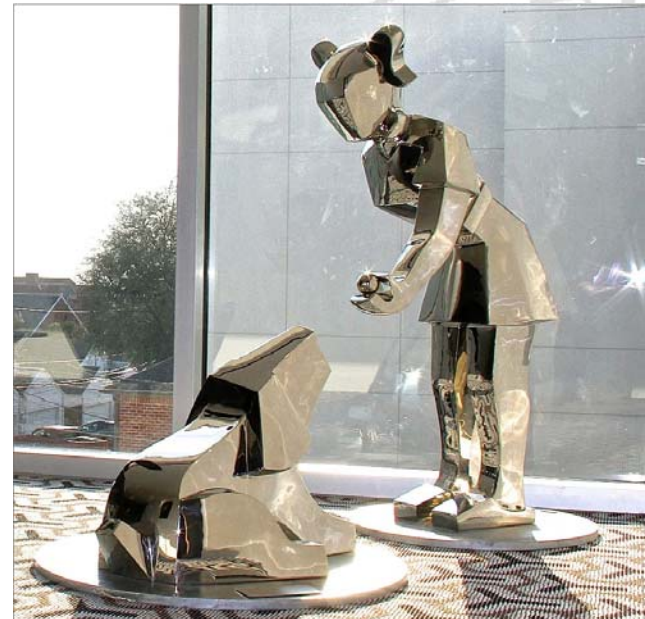
- Has extensive resume of site-specific sculptures for private and public-sector clients

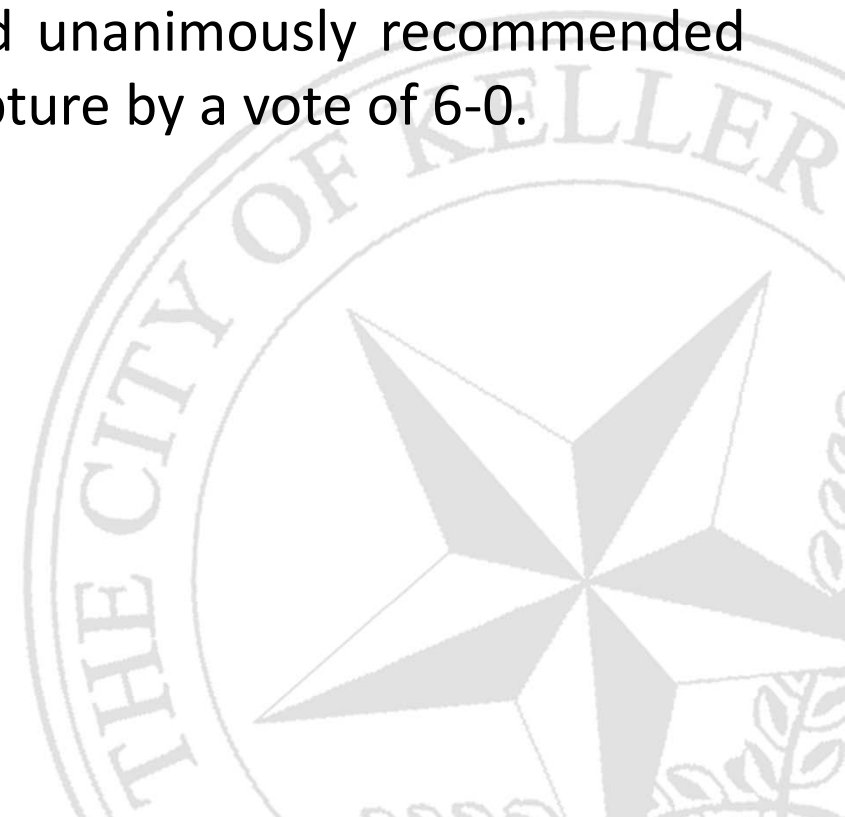
