## RESOLUTION NO. ####

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING AN INTERLOCAL AGREEMENT WITH TARRANT COUNTY, FOR THE REHABILITATION OF ROADWAYS AT VARIOUS LOCATIONS, FOR THE PUBLIC WORKS DEPARTMENT; AND FURTHER AUTHORIZING THE CITY MANAGER TO EXECUTE SAID AGREEMENT ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS,

during the 2025-2026 budget process, funding was allocated from the General Fund and Street System Capital Improvements Project Fund to provide paving materials to support a project with Tarrant County personnel to rehabilitate approximately 822 linear feet of Cheyenne Trail, 5,100 linear feet of North Pearson Lane, 1,400 linear feet of Willis Lane, 2,545 linear feet of Roanoke Road, 2,353 linear feet of Judge Bland Road, 700 linear feet of Lucian Lane, 1,439 linear feet of Oakhill Road, and 1,738 linear feet of Oak Trail, hereinafter referred to as the 2026 Tarrant Road Rehabilitation Project, and

WHEREAS,

Tarrant County Precinct No. 3 has agreed to provide the labor and equipment necessary for the completion of the 2026 Tarrant Road Rehabilitation Project; and

WHEREAS.

Tarrant County Precinct No. 3 has established an Interlocal Agreement that will enable Tarrant County to provide the construction resources necessary for the 2026 Tarrant Road Rehabilitation Project; and

WHEREAS,

the City Council of the City of Keller, Texas has deemed it necessary and in the best interest, health, and welfare of the citizens of Keller to move forward with the Interlocal Agreement with Tarrant County.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1:

THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2:

THAT, the City Council of the City of Keller, Texas hereby approves an Interlocal Agreement with Tarrant County for the rehabilitation and resurfacing of various roadways associated with the 2026 Tarrant Road Rehabilitation Project, attached hereto as Exhibit "A"; and further authorizes the City Manager to execute said Agreement on behalf of the City of Keller, Texas.

Section 3:

THAT, the cost of said Project by Tarrant County shall be paid from the Street System Capital Improvements Project Fund, with funding provided by the General Fund, in the amount of the actual costs for materials and equipment rental, which has been estimated to cost \$1,293,215.39, budgeted therefor.
