A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE BASE BID PROPOSAL WITH ALTERNATES FOR THE CITY-WIDE PAVEMENT MARKING SERVICES PROJECT, FROM LINEAR TRAFFIC MARKINGS LLC OF FORT WORTH, TEXAS, FOR THE PUBLIC WORKS DEPARTMENT, IN THE AMOUNT OF \$625,528.00 AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to maintain a properly functioning and striped street network; and

WHEREAS, the Base Bid Proposal with Alternates for City-Wide Pavement Marking Services for the Public Works Department provides for these services; and

WHEREAS, the TWO (2) sealed bids received on May 6, 2024 have been reviewed by staff, and it is determined that the bid from Linear Traffic Markings LLC. of Fort Worth, Texas, is the lowest and most responsible bid; and

WHEREAS, the City Staff recommends City-Wide Pavement Marking Services, provided by Linear Pavement Markings, of Fort Worth Texas, in the amount of \$625,528.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, City Council of the City of Keller, Texas, hereby approves the Base Bid with Alternates for City-Wide Pavement Marking Services from Linear Traffic Markings LLC. of Fort Worth, Texas.

Section 3: THAT, the cost of the said project shall be paid from the Street System Capital Improvements Project Fund, with funding provided by the General Fund in the amount of \$625,528.00, budgeted therefor.

Section 4: THAT, this resolution shall be effective upon its adoption.
