Special Use Permit Application for 640 Bancroft Rd. Keller, Texas

Current City of Keller regulations allows for a 1200 sq. ft. metal structure designated for Agricultural Use. Any size larger must apply for a Special Use Permit.

The Structure under consideration is a 1500 sq. foot Color Metal Building in dark brown for the roof and light tan for the walls. It will also contain a partial wrapped porch about 274sq. feet.

This structure will be a top of the line barn for show animals. The animals will be raised and cared for in cooperation with my three kids for their school 4-H projects.

The structure will be aesthetically pleasing and blending with the surrounding neighborhood. North Keller has larger properties and has many horses, cattle, and other livestock.


The primary nuisance potential is noise and odor. This will be mitigated by fully insulating the structure to help greatly diminish the noise. ORDINANCE NO. 1863

whereas, notice of a public hearing before the Planning and Zoning Commission was sent to real property owners within three hundred feet (300') of the property herein described at least ten (10) days before such hearing; and

WHEREAS, notice of a public hearing before the City Council was published in a newspaper of general circulation in Keller at least fifteen (15) days before such hearing; and

WHEREAS, public hearings to issue a Specific Use Permit on the property herein described were held before both the Planning and Zoning Commission and the City Council, and the Planning and Zoning Commission has heretofore made a recommendation to approve the Specific Use Permit; and

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

with the Unified Section 2: in accordance THAT. Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of a Specific Use Permit (SUP) for a 1,997 square-foot barn, located on 2.3-acres, on the south side of Bancroft Road, approximately 1,400 feet east of Bourland Road, at 640 Bancroft Road, being Lot 3, Block A, Leidy (Single Family Addition, and zoned SF-36 Residential - 36,000 square foot minimum), in the City of Keller, Tarrant County, Texas, with the proposal attached hereto as Exhibit "A", and incorporated herein, as if fully set forth with the condition below:

- 1. The SUP for a 1,997 square foot accessory building is contingent upon building the primary home as shown in Exhibit 'A'.
- corporation Section 3: THAT, any person, firm, or violating any of the provisions of this Ordinance, as read together with the Unified Development Code and accompanying map thereto, shall be guilty of a misdemeanor and upon final conviction therefore shall be fined in a sum not to exceed Two Thousand Dollars Each and every day (\$2,000.00). violation continues shall constitute separate offense and shall be punishable as such hereunder.

Section 4: THAT, the City Secretary is hereby authorized and directed to cause publication of the descriptive caption and penalty clause hereof as an alternative method of publication provided by law.
