

RESOLUTION NO. 3997

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING AN AGREEMENT WITH DATAVOX, OR HOUSTON, TEXAS, FOR THE PURCHASE, PROGRAMMING, AND INSTALLATION OF BUILDING SECURITY AND ACCESS CONTROL EQUIPMENT AND SOFTWARE FOR MULTIPLE CITY BUILDINGS, THROUGH THE STATE OF TEXAS DEPARTMENT OF INFORMATION RESOURCES (DIR) COOPERATIVE PURCHASING PROGRAM, IN A TOTAL AMOUNT OF \$126,971.08; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to upgrade the building security and access control system for multiple city buildings, for the Information Technology Department; and

WHEREAS, the Fiscal Year 2017-18 Annual Budget provided for the purchase of said Datavox services; and

WHEREAS, the purchase of said building security and access control upgrades from Datavox, of Houston, Texas, through the State of Texas Department of Information Resources (DIR) Cooperative Purchasing Program, has been determined to be the best value and most responsible method of purchasing therefor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves the agreement with Datavox, or Houston, TX, for the purchase, programming, and installation of building security and access control equipment in multiple city buildings, in the amount of \$126,971.08, through the State of Texas Department of Information Resources (DIR) Cooperative Purchasing Program, for the

Information Technology Department; and further authorizes the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said purchase of building security and access control upgrades, in the amount of \$126,971.08, for the Information Technology Department, shall be paid from the Information Technology Fund, budgeted therefor.
