Main Points that came out of the discussion: more artists needed, more advertising needed, bollards not to be placed until load-in is finished, time the larger ensembles in a manner that is more spaced out during the day, the potential to add an emcee, the idea of having a homecoming float to promote the event, and share event information with other local groups and on Next Door. Also discussed was the idea of having a special meeting next year solely dedicated to Art Walk.

Board requested interim city manager Aaron Rector to attend either the December or January meeting to discuss using KPAS funds for advertising/programming. Staff indicated they would check Mr. Rector's availability.

Chairperson Wyatt shared that there was a total of 14 applications submitted from Texas artists for the Keller Sports Park Mural call.

Board all asked that the call for art be extended.
