A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE PURCHASE OF ON-CALL CONCRETE INSTALLATION SERVICES FROM C.I. PAVEMENT, OF GRAND PRAIRIE, TEXAS, THROUGH THE INTERLOCAL PURCHASING SYSTEM (TIPS-USA) PURCHASING COOPERATIVE FOR THE PUBLIC WORKS DEPARTMENT RELATED TO THE 2026 SIDEWALK CONSTRUCTION PROJECT, IN AN AMOUNT NOT TO EXCEED \$785,000.00, AND AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE, TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has determined that it is necessary and in the best interest of the citizens of the City of Keller to purchase on-call concrete installation services for the Public Works Department; and

WHEREAS, such services are available through the Interlocal Purchasing System (TIPS-USA) purchasing cooperative; and

WHEREAS, the use of a cooperative purchasing agreement is authorized under Chapter 791 of the Texas Government Code; and

WHEREAS, C.I. Pavement, of Grand Prairie, Texas, holds a valid cooperative purchasing agreement through TIPS-USA; and

WHEREAS, City staff recommends the purchase of on-call concrete installation services from C.I. Pavement, of Grand Prairie, Texas, in an amount not to exceed \$785,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves the purchase of on-call concrete installation services from C.I. Pavement, of Grand Prairie, Texas, through the TIPS-USA purchasing cooperative, in an amount not to exceed \$785,000.00, and authorizes the City Manager, or his designee, to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of the on-call concrete installation services shall be paid from the Street System Capital Improvement Project Fund.

Section 4: THAT, this resolution shall be effective upon its adoption
