A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF KELLER, TEXAS, APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH FRONT LINE MOBILE HEALTH, OF GEORGETOWN, TEXAS; FOR THE PURPOSE OF PROVIDING ANNUAL PHYSICALS TO FIRE AND POLICE DEPARTMENT PERSONNEL, PHYSICALS AND PSYCHOLOGICAL EVALUATIONS TO NEW HIRES, AND A FITFOR-DUTY PROGRAM FOR A ONE (1) YEAR PERIOD WITH FOUR (4) ADDITIONAL ONE (1) YEAR RENEWAL PERIODS, NOT TO EXCEED FIVE (5) YEARS, AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

- WHEREAS, quality annual physical examinations that meet National Fire Protection Association (NFPA) 1582 Standards are necessary to maintain a quality health and wellness program that will allow our firefighters to have a long, healthy career; and
- WHEREAS, the city desires to have a "One-Stop-Shop" for all of the Annual Physicals, New Hires, and Return to Duty physical examinations for Keller Police and Keller Fire Rescue; and
- WHEREAS, cost of said medical services is estimated to be \$75,000 annually with funding provide from the Self-Insurance fund for current employees and the General Fund Human Resources Department for new hires; and
- WHEREAS, city staff has reviewed the qualifications of Front Line Mobile Health, of Georgetown, Texas, and determined this provider is well qualified to provide the professional services for said medical services; and
- WHEREAS, city staff recommends Front Line Mobile Health, of Georgetown, Texas to be used to perform the necessary professional medical services relating to Pre-Employment Evaluations, Annual Medical Evaluations, and Psychological Evaluations as set forth in the agreement for said medical services; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, the City Council of the City of Keller, Texas hereby approves a Professional Services Agreement with Front Line Mobile Health, of Georgetown, Texas, for the purpose of providing annual physicals to fire and police department personnel, physicals and psychological

evaluations to new hires, and a fit-for-duty program; for a one (1) year period with four (4) additional one (1) year renewal periods, not to exceed five (5) years, and further authorizes the City Manager to execute all contract documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said medical services shall be paid by the City's Self-

Insurance Fund.

Section 4: THAT, this resolution shall be effective upon its adoption.
