

RESOLUTION NO. 4374

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, AMENDING RESOLUTION NO. 4368, APPROVED ON JUNE 1, 2021, CREATING A KELLER SPORTS PARK TASK FORCE, BY ADDING AN ADDITIONAL MEMBER TO SAID KELLER SPORTS PARK TASK FORCE, AND PROVIDING AN EFFECTIVE DATE.
