

RESOLUTION NO. 4214

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, AMENDING RESOLUTION NO. 4210, DATED JANUARY 21, 2020, CALLING THE GENERAL ELECTION FOR MAYOR, CITY COUNCIL PLACE 5, AND CITY COUNCIL PLACE 6 FOR THE CITY OF KELLER, TO BE HELD ON MAY 2, 2020, AS SET FORTH BY THE CHARTER AND BY THE TEXAS ELECTION CODE.

WHEREAS, the City Council of the City of Keller, Texas approved Resolution No. 4210 dated January 21, 2020, calling the General Election for Mayor, City Council Place 5, and City Council Place 6, to be held on May 2, 2020, in the City of Keller, Texas; and

WHEREAS, Early voting by personal appearance shall be conducted at the Main Early Voting Location: Tarrant County Election Center, 2700 Premier Street, Fort Worth, Texas 76111, at Keller Town Hall, 1100 Bear Creek Parkway, Keller, Texas 76248, and at all other locations in Tarrant County as established by the Tarrant County Elections Administrator.

WHEREAS, Election Day voting shall be conducted at Keller Town Hall, 1100 Bear Creek Parkway, Keller, Texas 76248, and at all other locations in Tarrant County as established by the Tarrant County Elections Administrator.

WHEREAS, Tarrant County Elections Administrator has hereby advised that any run-off necessitated by the General Election will be held on Saturday, June 20, 2020 as designated by the Joint Election Agreement and Contract for Election Services with Tarrant County, in accordance with the Texas Election Code.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, Resolution No. 4210, dated January 21, 2020, is hereby amended to include the polling locations for early voting, polling locations for Election Day, and the date for any Runoff election to be held changed to June 20, 2020.

Section 3: THAT, all provisions of Resolution No. 4210 not hereby amended shall remain in full force and effect.

Section 4: THAT, this resolution shall be effective upon its adoption.
