I received contact from The City of Keller that we would have to remove our north facing sign (see photo attached-1). This sign uses existing bracketing and lighting and is to the same specs as the previous business owner's, Roscoe's Smokehouse, sign (see photo attached-2). It is a permanent part of this building. This sign also serves as a directional sign for our business. Without the sign, there would just be a tacky bracket with useless lighting. And just to note, our signage also follows almost exact style and content as Old Town Ice House, our neighbor right next door (photos also attached-3,4).

As per recommendation, our sign company re-submitted a plan to reduce the size of the sign and we were informed that it was still denied due to code. A sign permit was submitted. The sign is externally illuminated with spotlights that precede the sign and are permanently affixed to the building. The sign in question is a metal sign attached to wood brackets, which are also permanently affixed to the building, and is painted. The colors and content are very well compatible with the architecture and the business that it identifies.

As a female business owner, I am trying to build a business in a location where the two previous businesses have failed; as well as support the community that I love. I've taken a drab building with dead shrubs and have refreshed, not only its interior look, but also the curb appeal for residents and visitors to our great city.
