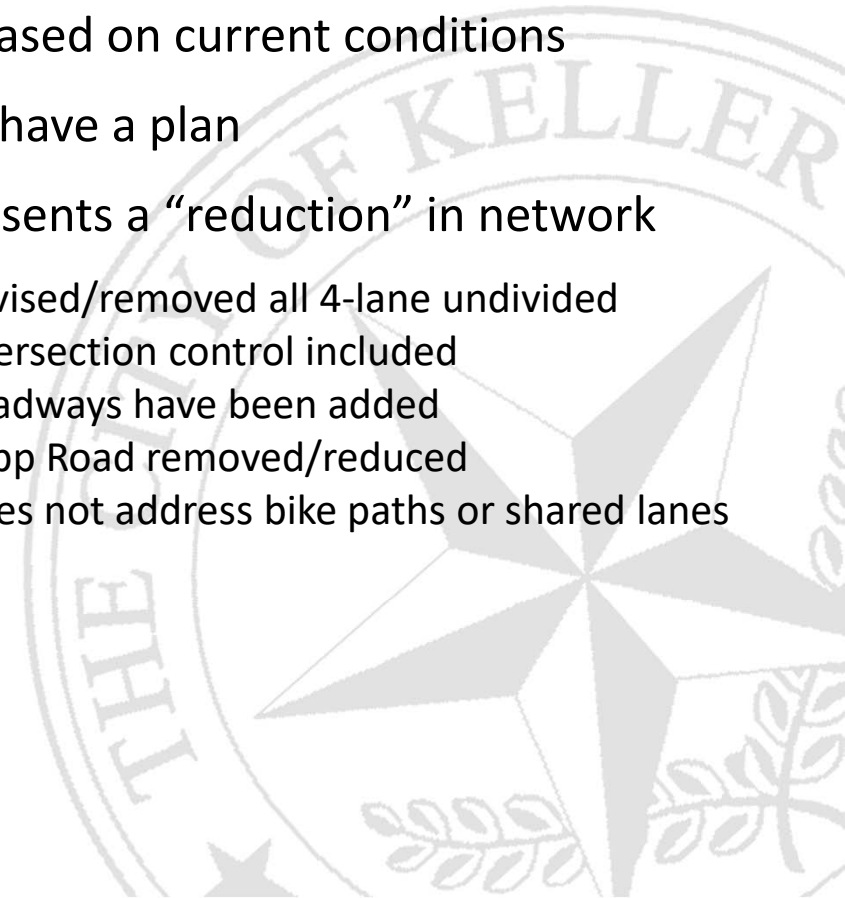
Response to Questions

Impact Fees

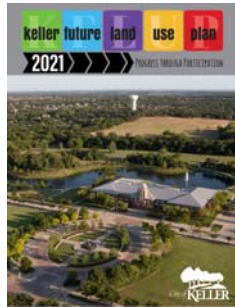
- Not a Tax Increase
- Assessed on New/Expanded
- Reduces what “the rest of us pay”

MTP

- Not based on current conditions
- Must have a plan
- Represents a “reduction” in network
 - Revised/removed all 4-lane undivided
 - Intersection control included
 - Roadways have been added
 - Rapp Road removed/reduced
 - Does not address bike paths or shared lanes

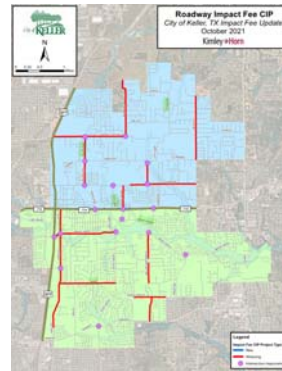
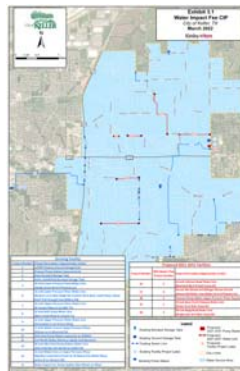
