## ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A SPECIFIC USE PERMIT (SUP) FOR AN APPROXIMATELY 2,400 SQUARE-FOOT ACCESSORY STRUCTURE WITH AN AVERAGE HEIGHT OF 14 FEET 8 INCHES, ON APPROXIMATELY 4.17 ACRES, ON THE WEST SIDE OF KELLER SMITHFIELD ROAD, APPROXIMATELY 680 FEET SOUTHWEST FROM THE INTERSECTION OF KELLER SMITHFIELD ROAD AND OTTINGER ROAD, LEGALLY DESCRIBED AS LOT 1R, BLOCK A OF THE OUR LADY OF THE FIELDS SUBDIVISION, ZONED SINGLE-FAMILY 36,000 SQUARE-FOOT LOT SIZE OR GREATER (SF-36) AND ADDRESSED 760 KELLER SMITHFIELD ROAD IN THE CITY OF KELLER, TARRANT COUNTY, TEXAS; PROVIDING A PENALTY; AND AUTHORIZING PUBLICATION.

- WHEREAS, William Starck, Applicant/Owner, submitted a request for a Specific Use Permit (SUP-23-0034) for an approximately 2,400 square-foot accessory structure in the SF-36 Zoning District; and
- WHEREAS, the City's Planning and Zoning Commission and the City Council, in accordance with the Charter of the City of Keller, State Law, and the ordinances of the City of Keller, have given the required notices and have held the required public hearings regarding the SUP application described in this ordinance; and
- WHEREAS, the City Council is of the opinion the SUP request herein effectuated furthers the purpose of zoning as set forth in the Unified Development Code and is in the best interest of the citizens of the City of Keller.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, in accordance with the Unified Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of an Specific Use Permit (SUP) to construct an approximately 2,400 square-foot accessory structure, on approximately 4.17 acres, on the west side of Keller Smithfield Road, approximately 680 feet southwest from the intersection of Keller Smithfield Road and Ottinger Road, legally described as Lot 1R, Block A of the Our Lady of the Fields Subdivision, zoned Single-Family 36,000 square-foot lot size or greater (SF-36) and addressed 760 Keller Smithfield Road, as if fully set forth with the following conditions:

- 1. A Specific Use Permit for an accessory structure in excess of 1,200 square-feet in the SF-36 zoning district shall be allowed.
- 2. A Specific Use Permit for the combined square footage of accessory structures on the property to be in excess of 50% of the main dwelling unit's square footage shall be allowed.
- Section 3:

THAT, any person, firm or corporation violating any of the provisions of this Ordinance shall be guilty of a misdemeanor and upon final conviction therefor, shall be fined in a sum not to exceed two thousand dollars (\$2,000.00). Each and every day any such violation continues shall constitute a separate offense and shall be punishable as such hereunder.

Section 4:

THAT, the City Secretary is hereby authorized and directed to cause publication of the descriptive caption hereof as an alternative method of publication provided by law.
