Who is The Tiki Hut of Keller?

The Tiki Hut of Keller, TX was founded in 2003 and has been located in the Keller area since that time, in Mr. Jim's Pizza parking lot at, 705 S. Main in Keller, TX. Owned by Cathy and Eric Smith of Keller, TX. We take great pride in our facilities as each building is maintained to look like new each and every year.

Our entire business is designed to fit neatly into 4 parking spaces. 1 to $1\frac{1}{2}$ spaces are used for the building and our exterior ice merchandiser/freezer, and the remainder is used for our seating area. Our buildings are $10 \times 10 \times 8$. The exterior is wood and is painted white. Mounted flush on the building will be our menu and our signage.

Due to the Texas heat, we sometimes use removable umbrellas that attach to our tables to provide shade for our patronage. We do not use tents, tarps or any other form of a shade structure.

Additional lighting is not required for our business. We do, however, use indirect lighting in the customer ordering area.

Our buildings are totally self-contained. We bring in fresh water daily and keep a day's worth of reserve, so fresh water is always available. It is added to the holding tank as needed. A pressurized demand pump system is used to allow water to flow, so access to a city water line is not required. Buildings are also equipped with a portable waste water (gray water) holding tank that is removed each night and disposed of through the city sewer system at our residence.

In September 2007, the Star Telegram asked readers to tell them about their favorite one room restaurants, The Tiki Hut of Keller was voted the Best Snow Cone stand in Northeast Tarrant County. The newspaper article is attached for your enjoyment.

Also, included are some current pictures from our past season at the location located at 705 S Main and as you can tell it is definitely a family place. It is not uncommon to see entire families here enjoying an evening together.

Our locations are open seasonally, April – August of each year. We are open daily, Sunday – Saturday (weather permitting), 3pm – 9pm.

What do we offer as a tenant?

The Tiki Hut of Keller is a favorite spot for many families of the Keller area. Many people are regular, daily customers who are incredibly happy when we open April 1 of every year and incredibly saddened when we close at the end of each August. While many people wish for The Tiki Hut to stay opened year round, we have found that operating seasonally keeps the customers wanting more. We offer a professionally maintained facility complete with corporate graphics (see attached photo). As a tenant of the locations we currently occupy, we have successfully brought attention to other businesses that quite possibly would have been overlooked by people had they not stopped at our location. 



Snow cone stand a 'people business'

It's snowing in Keller, but not or much longer: The summer is echnically over, but snow cones re still being sold.

The "oasis of shave ice euphoia" that is Tropical Sno, dubbed he "highest quality and bestasting shave ice in the world," ccording to the company's Web ite, is still selling Tiger's.

That's the most popular flaor, according to Kathy Smith, a oncoction of 60 percent strawerry and 40 percent coconut.

Flavors range from Wedding Cake, a mix of vanilla and cocout, to Lovers Delight, a passion ruit and guava mix.

David Hayes, one of the servrs, said he likes his summer job it the hut. He's normally at the Celler Parkway location in the Celler Crossing shopping center. Hays says undecided customers isually get sized up for their weet or sour preferences.

"Some want a deep flavor," he said. "Kids usually get the cotton andy or bubble gum," and Dads, "they get the Cherry 3laster."

Moms? They "like to mix it up a lot." Some like Pina Colada and Georgia Peach – which he says "tastes pretty close" to the ruit.

He's a graduate of Grapevine Faith Academy and like many

others after high school, keeps coming back to work for Smith.

At the U.S. 377 location, four students just out of band camp practice at Keller High School finish off a cool cup.

"Whenever it comes up in the subject, we've got to go," Jasmine Ashford said of the decision process that led them to the hut that day.

The decision was "pretty much unanimous," said Kate Kidd. After a long, grueling sixhours day of band practice, it was a much-needed treat.

Their favorite? Tiger's Blood. "It's just nice how it melts in your mouth," said Collin Kidd.

"It's a good sugar rush."

Though some in the group didn't know much about the Tiki Hut, they all expected to be back.

The Tiki Hut of Keller is serving up flavor from two locations and one in Fort Worth off Golden Triangle and Beach Street.

The Keller Parkway location will close the end of August, but the U.S. 377 location will stay open through September. Every year, the small huts open for business between 1 and 10 p.m. seven days a week and provides summer jobs for 12 to 16 kids, said Smith.

"It's a people business," she said.

run a hut? Smith isn't exactly sure but says, on average, "we go through at least ten bags of ice a day – 20 blocks."

Flavor run-outs have never been a big problem, but strawberry "most definitely" is usually the first to go.

Smith's favorite flavor – Wedding Cake, a vanilla and coconut mix; "It's very sweet."

The "actual flakes" makes shaved better, she said. But going into business, though time consuming, is "a lot of fun."

"We've got a lot of regulars and some of the people I've become friends with."

This year they began donating

50 cents to help fight breast cancer for every customer who buys pink lemonade and pink grapefruit flayors.
