

ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A REQUEST FOR A SPECIFIC USE PERMIT (SUP) WITH A VARIANCE, FOR A 375 SQUARE-FOOT CARPORT, ON .89 ACRES, LOCATED ON THE SOUTH SIDE OF TREEHOUSE LANE SOUTH, APPROXIMATELY 1075 FEET EAST FROM THE INTERSECTION OF OTTINGER AND TREEHOUSE LANE SOUTH, LEGALLY DESCRIBED AS LOT 21, BLOCK 1 OF THE TREEHOUSE ADDITION, ZONED SINGLE-FAMILY 36,000 SQUARE-FOOT LOT SIZE OR GREATER (SF-36) AND ADDRESSED 1526 TREEHOUSE LANE SOUTH., IN THE CITY OF KELLER, TARRANT COUNTY, TEXAS; PROVIDING A PENALTY; AND AUTHORIZING PUBLICATION.

WHEREAS, William Pataky, Applicant, and Richard and Mary Lou Mills, Owners, submitted a request for a Specific Use Permit (SUP-2602-0003) for a 375 square-foot carport with a variance in the SF-36 Zoning District; and

WHEREAS, the City's Planning and Zoning Commission and the City Council, in accordance with the Charter of the City of Keller, State Law, and the ordinances of the City of Keller, have given the required notices and have held the required public hearings regarding the SUP application described in this ordinance; and

WHEREAS, the City Council is of the opinion the SUP request herein effectuated furthers the purpose of zoning as set forth in the Unified Development Code and is in the best interest of the citizens of the City of Keller.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, in accordance with the Unified Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of an Specific Use Permit (SUP) with a variance, for a 375 square-foot carport, on .89 acres, located on the south side of Treehouse Lane South, approximately 1075 feet east from the intersection of Ottinger and Treehouse Lane South, legally described as Lot 21, Block 1 of the Treehouse Addition, zoned Single-Family 36,000 square-foot lot size or greater (SF-36) and addressed 1526 Treehouse Lane South, as if fully set forth with the following conditions:

1. A Specific Use Permit for a carport in the SF-36 zoning district shall be allowed.

2. A variance to allow for more than 2 accessory structures on the property shall be granted.

Section 3: THAT, any person, firm or corporation violating any of the provisions of this Ordinance shall be guilty of a misdemeanor and upon final conviction therefor, shall be fined in a sum not to exceed two thousand dollars (\$2,000.00). Each and every day any such violation continues shall constitute a separate offense and shall be punishable as such hereunder.

Section 4: THAT, the City Secretary is hereby authorized and directed to cause publication of the descriptive caption hereof as an alternative method of publication provided by law.
