A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE A FRANCHISE AGREEMENT WITH COMMUNITY WASTE DISPOSAL (CWD), OF DALLAS, TEXAS, PROVIDING FOR CITYWIDE SOLID WASTE COLLECTION AND RECYCLING SERVICES, FOR A TERM OF FIVE (5) YEARS BEGINNING SEPTEMBER 1, 2026 AND TERMINATING AUGUST 31, 2031, WITH ONE (1) FIVE-YEAR RENEWAL OPTION; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, it has been determined by the City Council of the City of Keller, Texas, that it is in the best interest of the health, safety, and general welfare of the citizens of the City of Keller to provide citywide solid waste collection and recycling services; and

WHEREAS, the City issued and duly advertised a request for proposals for citywide solid waste collection and recycling services and proposals were received at 4:00 p.m., on Monday, May 18, 2026; and

WHEREAS, proposals were reviewed and evaluated in accordance with the request for proposals, and Community Waste Disposal (CWD), of Dallas, Texas, was selected as the recommended provider for citywide solid waste collection and recycling services; and

WHEREAS, in accordance with the terms and conditions set forth therein, it is hereby determined to be in the best interest of the citizens of the City of Keller to approve the franchise agreement with Community Waste Disposal (CWD), attached hereto as Exhibit "A," providing for citywide solid waste collection and recycling services, for a term of five (5) years beginning September 1, 2026 and terminating August 31, 2031, with one (1) five-year renewal option.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves the franchise agreement with Community Waste Disposal (CWD), of Dallas, Texas, attached hereto as Exhibit "A," providing for citywide solid waste collection and recycling services, for a term of five (5) years beginning September 1, 2026 and terminating August 31, 2031, with one (1) five-year renewal option; and further authorizes the City Manager to execute

all contract documents relating thereto on behalf of the City of Keller,
Texas.
