



Train and Tracks, Cargo of Grapes, the 2 Brothers and the Keller Water Tower
(Approximately 310 sq. ft. mural space on exterior south side wall)

TERMS & CONDITIONS:

Payment Schedule:

- a. A non-refundable deposit of 1/2 the total cost of all selected services and total cost of all materials/supplies is due prior to purchase of materials and rendering of services.
- b. Remaining balance will be paid in equal weekly installments due every Friday by 3:00 PM for the projected duration of the project until completed.
- c. A final payment of the remaining amount including any change orders will be due on the final day of completion.
- d. We gladly accept Visa, Master Card, Discover, and American Express for your convenience. An additional 3.85 % will be added to the total sum of services rendered for customers paying by credit cards.
- f. “A Work of Art!” will be given permission to utilize photographs taken by our company photographer of work performed by “A Work of Art!” for the purposes of advertisement, web-site display and portfolio exhibition.

In all cases our proposal and/or contractual agreement is based on the following:

- a. Access to worksite. If no one is home during normal working hours please provide a key, keypad combination, or garage door opener for access. Also please provide a contact number in case of questions or an emergency.
- b. Customer is responsible for removal of any and all furniture and furnishings from work area prior to the commencement of work, this permits “A Work of Art!” to effectively perform the service which is previously stated in this Scope of Work and contract. “A Work of Art!” personnel are not permitted to move furniture or Furnishing; remove pictures or decorative items, curtains and/or accessories.
- c. Customer is responsible for surface areas that have been properly prepared for decorative finishing, including patchwork, grouting, and primer, painting applications. “A Work of Art!” is not responsible for surface integrity not applied by “A Work of Art!”
- d. Client is responsible for keeping pets and children away from the work area to insure their safety and avoid mishaps.
- e. “A Work of Art” retains all rights to any proposed sketches, rough drafts, samples boards, design work, stencils and/or concepts, in any form resulting from the engagement with the customer.
- f. At times it is necessary to erect scaffolding to render services. At these times scaffolding will remain in the work area until completion of that services. For everyone’s safety it is the customer’s responsibility to keep all adults and children off the scaffolding at all times.
- g. Our proposal to the customer is calculated by industry standard for the time, labor, and materials required to perform services for which we are hired. If at any time the customer requires to observe or assist in the process of rendering these services an additional hourly rate will be incurred by the customer. Teaching the customer to perform our specialized trade requires additional labor hours, these labor hours will incur an additional charge to the customer.
- h. Prices quoted in this proposal/scope of work will be honored for 90 days from date stated at the top of proposal/scope of work.
