RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF KELLER, TEXAS, APPROVING A THREE-YEAR CONTRACT WITH DATAVOX, FOR ARCTIC WOLF MANAGED DETECTION AND RESPONSE CYBERSECURITY SERVICES, IN AN AMOUNT NOT TO EXCEED \$240,000.00; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASING AND CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

- WHEREAS, the City of Keller, Texas requires additional tools and services to further secure all City devices, networks, systems, and information; and
- WHEREAS, the City of Keller, Texas has determined the most effective and economical solution is to utilize a third-party, managed cybersecurity solution; and
- WHEREAS, Arctic Wolf Networks has contracted through the Texas Department of Information Resources with Datavox, for cooperative purchasing and managing of Arctic Wolf cybersecurity services for State of Texas agencies and local governments; and
- WHEREAS, the Texas Department of Information Resources Cooperative Purchasing Program meets all State and local competitive bidding requirements, while also providing a cooperative purchasing network where all State and local governments can benefit from the collective shared purchasing power; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, the City Council of the City of Keller, Texas hereby approves a three–year contract with Datavox, for Arctic Wolf managed detection and response cybersecurity services, attached hereto as Exhibit "A", in an amount not to exceed \$240,000.00; and further authorizes the City Manager to execute all purchasing and contract documents relating thereto on behalf of the City of Keller, Texas.
- Section 3: THAT, the cost of said three-year contract with Datavox, for Arctic Wolf managed detection and response cybersecurity services, in an amount not to exceed \$240,000.00, shall be paid from the Information Technology Fund budgeted therefor.
