

RESOLUTION NO. 5026

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, RATIFYING A PURCHASE AGREEMENT WITH SARATOGA RACK MARKETING LLC dba TARTAN OIL LLC., FOR UNLEADED GASOLINE AND DIESEL FUEL PURCHASES, FOR THE CITY OF KELLER, AS AWARDED BY THE TARRANT COUNTY COMMISSIONERS' COURT, TEXAS ON MARCH 14, 2023, UTILIZING A COOPERATIVE PURCHASING INTERLOCAL AGREEMENT BETWEEN THE CITY OF KELLER AND THE CITY OF FORT WORTH.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to approve a purchase agreement for unleaded and diesel fuel purchases for The City of Keller, Texas; and

WHEREAS, the Texas Local Government Code 271.102 authorizes participation in a cooperative purchasing program with another local government or a local cooperative organization; and

WHEREAS, the City of Keller, Texas desires to increase efficiency and effectiveness by participating in purchasing of goods and services through cooperative purchasing, thereby satisfying competitive bid requirements; and

WHEREAS, The Commissioners' Court of Tarrant County, Texas authorized the purchase agreement with Tartan Oil LLC. for unleaded and diesel fuel for the period April 7, 2023, through April 6, 2024, with options to renew for three (3) additional one-year periods; and

WHEREAS, the unleaded and diesel fuel purchases bid from Tartan Oil LLC through the cooperative purchasing program has been determined to be the lowest and most responsible method of purchasing unleaded fuel therefore.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas, hereby ratifies a purchase agreement with Tartan Oil LLC for unleaded and diesel gasoline fuel purchases, for the City of Keller, as awarded by Tarrant

County, Texas on March 14, 2023, for the period April 7, 2023 through April 6, 2024, with options to renew for three (3) additional one year periods, utilizing a cooperative purchasing interlocal agreement between the City of Keller and Tarrant County.

Section 3: THAT, the cost of said unleaded fuel purchases be paid from the various funds and departments budgeted therefore.
