D. OLD BUSINESS

1. [Consider a City of Keller Façade Improvement Grant request for 207 S Elm Street, Keller, TX 76248](#)

This item was initially tabled to the December 2023 Economic Development Board meeting in order for the applicant to provide more information on the request. However, the applicant met all requirements and requested that the item be presented at the November Economic Development Board meeting.

Mayor Armin Mizani made a motion to untable the item which was seconded by Mr. Erik Leist. The motion passed unanimously.

Mr. Siale Langi presented the \$10,000 grant request for the demolition of the structure on site in preparation for a new commercial building. The estimated cost for the demolition portion of the project is \$10,500.

Mr. Erik Leist motioned to recommend approval of the Façade Improvement Grant request with the condition that the reimbursement be made after a building permit for the new structure is approved by the city. Mr. Nate Bernklau seconded and the motion passed by a vote of 5 to 1.
