Mrs. Mary Culver presented the \$10,000 grant request for eligible improvements for Café Medi, which included: replacing the deck/patio, landscaping and replacing lamp posts.

- 3. <u>Consider Chapter 380 Economic Development Incentive Request for a project located at 401 Golden Triangle Blvd.</u>, Keller, TX 76248.
