A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF KELLER, TEXAS, APPROVING THE BID FOR THE PATE ORR SIDEWALK IMPROVEMENTS PROJECT FROM GREEN DREAM INTERNATIONAL, LLC OF IRVING, TEXAS, FOR THE PUBLIC WORKS DEPARTMENT, IN THE AMOUNT OF \$646,024.80; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, it has been determined by the City Council of the City of Keller, Texas, that it is in the best interest of the health, safety and general welfare of the citizens of the City of Keller, Texas to design and construct the Pate Orr Sidewalk Improvements Project; and

WHEREAS, the nine (9) sealed bids received on August 24, 2022 have been reviewed by staff, and it is determined that the bid from Green Dream International, LLC of Irving, Texas, in the amount of \$646,024.80 is the lowest and most responsible bid; and

WHEREAS, funds for this work are budgeted in the Street System Capital Improvements Project Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the bid for the Pate Orr Sidewalk Improvements Project, from Green Dream International, LLC of Irving, Texas for the Public Works Department, in the amount of \$646,024.80; and further authorizes the City Manager to execute all contract documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, a budget amendment is required to move the necessary funds from the Drainage System Capital Improvements Project Fund to the Street System Capital Improvements Project Fund for said project.

Section 4: THAT, the cost of said project shall be paid from the Street System Capital Improvements Project Fund, with funding provided by the General Fund and Drainage Utility Fund, in the amount of \$646,024.80, budgeted therefor.

Section 4: THAT, this resolution shall be effective upon its adoption.
