A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, FOR A SITE PLAN WITH ONE VARIANCE TO THE KELLER PARKWAY LANDSCAPE BUFFER REQUIREMENT RELATED TO THE ALTUS DEVELOPMENT OF TWO BUILDINGS (4,000 SQUARE-FOOT MEDICAL BUILDING AND 16,722 SQUARE-FOOT GENERAL OFFICE BUILDING), LOCATED ON AN APPROXIMATELY 2.42-ACRE TRACT OF LAND, THE NORTH SIDE OF KELLER PARKWAY, APPROXIMATELY 125' NORTHWEST OF THE INTERSECTION OF BLOOMFIELD DRIVE AND KELLER PARKWAY, BEING LOT 3, BLOCK A OF BOWDEN EVENT CENTER ADDITION, AND ADDRESSED AS 1807 KELLER PARKWAY, AND ZONED R (RETAIL) IN THE CITY OF KELLER, TARRANT COUNTY, TEXAS.

- WHEREAS, the owner/applicant, KP BOWDEN LLC ("Bowden"), submitted a site plan (SP-20-008) to develop two buildings (a 4,000 square-foot medical building and a 16,722 square-foot general office building); and
- WHEREAS, Bowden desires to construct more parking than is required by the Unified Development Code (UDC); and
- WHEREAS, Bowden proposes to add additional parking spaces, at least six of which will encroach up to eleven feet into the required landscape buffer along Keller Parkway; and
- WHEREAS, the Planning and Zoning Commission recommended approval by a vote of \_\_ to \_\_at its April 14, 2020, and
- WHEREAS, the City Council finds that the request meets the criteria to grant variances per Section 2.07 of the Unified Development Code based on \_\_\_\_\_\_;

- Section 2: THAT, the site plan for property located on approximately 2.42-acres of land on the north side of Keller Parkway, approximately 125-feet northwest of the intersection of Bloomfield Drive and Keller Parkway, being Lot 3, Block A of Bowden Event Center Addition and addressed as 1807 Keller Parkway, attached hereto as Exhibit "A", and incorporated herein as if fully set forth, with the following variance:
  - 1) Allow for parking to encroach the 30-foot, Keller Parkway Landscape Buffer up to 11 feet on the south side of the property.
