Good afternoon Shane, Chad, Alonzo, Sarah, Katasha and Amber;

I was discouraged to hear that the Winding Creek subdivision plans include a shortcut from Johnson Road/Greenbriar to Pearson Crossing/Pearson Lane (near 1709). I just viewed a recording of this Tuesda's P&Z and saw that City Staff has asked that the developer to open our safe and quiet cul-de-sac into a through street.

I believe the cut-through from Johnson to Pearson Lane would create more safety concerns than it would solve. Kids in Pearson Crossing frequently bike or walk down the street to to meet neighbors or walk to/from the Pearson Xing/Pearson Lane school bus stop. It is rare to see cars staying on the correct side of the street due to the street sinking in various places and the asphalt along the sides breaking off. Pearson Crossing doesn't have sidewalks or cross walks.

Please consider updating the master thoroughfare plan and the Winding Creek site plan to keep traffic from traveling through Winding Creek to Pearson Crossing. Or - if access is needed, please only allow emergency access to Pearson Crossing instead of connecting the two subdivisions to make a cut-through.

I appreciate the hard work you do every day to keep us safe here in Keller.
