## RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, AMENDING RESOLUTION NO. 1051, DATED AUGUST 31, 1998, BY AMENDING THE LAND USE ELEMENT OF THE CITY OF KELLER MASTER PLAN AND THE FUTURE LAND USE PLAN/MAP IN THE CITY OF KELLER, TARRANT COUNTY, TEXAS.

WHEREAS,	Contour Real Estate and Development, Applicant; Garland All
	Associates, Owner; have submitted an application (LUP-21-0001) to
	amend the Land Use Element of the City of Keller Master Plan and
	Future Land Use Plan/Map, for approximately 21.98 acres legally
	described as Tract 9C02K, Tract 9C02, Tract 9C02J, Tract 9C02H, Tract
	9C02E, Tract 9C02F, Tract 9C02B, Tract 9C02C, Tract 9C02D out of
	the Holland, WJ Survey, Abstract No. 692, located on the northwest
	corner of the Wall-Price Keller Road and Whitley Road intersection, from
	Industrial Commercial (IC) to Mixed-Use (MU); and

- WHEREAS, a public hearing before the Planning and Zoning Commission was held on February 23, 2021, to receive public input; and

- WHEREAS, a public hearing before the City Council was held on March 16, 2021, to receive public input; and
