A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE PURCHASE OF A 2024 VACCON VACUUM AND HYDRO EXCAVATION TRUCK IN THE AMOUNT OF \$541,897.75 FROM HOUSTON FREIGHTLINER, OF HOUSTON, TEXAS THROUGH THE HGACBUY PURCHASING COOPERATIVE; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to purchase a replacement vacuum and hydro excavation truck for the City of Keller; and

WHEREAS, the Proposed Fiscal Year 2023-24 Water & Wastewater Utility Fund and Fleet Replacement Fund budgets provide for the purchase of said vehicle in the amount of \$550,000; and

WHEREAS, the purchase from Houston Freightliner, of Houston, Texas through the HGACBuy Purchasing Cooperative has been determined to be the lowest and most responsible method of purchasing.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves the purchase of a 2024 VacCon vacuum and hydro excavation truck from Houston Freightliner, of Houston, Texas through the Buyboard Purchasing Cooperative in the amount of \$541,897.75; and further authorizes the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost to purchase said VacCon vacuum and hydro excavation truck, and related equipment, shall be paid from Fleet Replacement Fund using funds from the Water & Wastewater Utility Fund, in the amount of \$541,897.75 budgeted therefor.
