Mr. Mark Murphy owner of Bear Creek Running Company spoke to the Board about a Matching Grant Application. Mr. Murphy would like to add a shade structure near the K9 Park and the Parkrun starting point. Mr. Murphy is willing to match the funds by half. Director of Community Services Cody Maberry provided a presentation on the proposed shade structure. The board had questions on funding, total cost, and logos. The Park Board is in favor to move forward with the grant matching opportunity.

The board had questions about number of residents and non residents, activities other than classes, next steps and cost benefits analysis. The board encouraged Mr. Queen to speak to City Council to advocate for additional hours and staff.
