RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING AN INTERLOCAL AGREEMENT WITH TARRANT COUNTY, FOR THE REHABILITATION OF BEAR CREEK PARKWAY FROM WHITLEY ROAD TO RUFE SNOW DRIVE AND SPRING BRANCH DRIVE FROM OAK VALLEY DRIVE TO CUL DE SAC, FOR THE PUBLIC WORKS DEPARTMENT; IN AN ESTIMATED AMOUNT OF \$704,622.78; AND FURTHER AUTHORIZING THE CITY MANAGER TO EXECUTE SAID AGREEMENT ON BEHALF OF THE CITY OF KELLER, TEXAS.

- WHEREAS, during the budget process for Fiscal Year 2022-23, funding was allocated from the Street System Capital Improvement Project Fund budget to provide paving materials to support a project for Tarrant County personnel to rehabilitate approximately 6,379 feet of Whitley Road from Rapp Road to North Tarrant Parkway; and
- WHEREAS, resulting budget savings from that project in the approximate amount of \$934,500 shall be utilized for another, similar project; and
- WHEREAS, those savings have been identified to be utilized for the rehabilitation of approximately 5,671 feet of Bear Creek Parkway from Whitley Road to Rufe Snow Drive, and 345 feet of Spring Branch Drive from Oak Valley Drive to Cul de Sac, hereinafter referred to as the Project, and
- WHEREAS, Tarrant County Precinct No. 3 has agreed to provide the labor and equipment necessary for the completion of the Project; and
- WHEREAS, Tarrant County Precinct No. 3 has established an Interlocal Agreement that will enable Tarrant County to provide the construction resources necessary for the Project; and
- WHEREAS, the City Council of the City of Keller, Texas has deemed it necessary and in the best interest, health, and welfare of the citizens of Keller to move forward with the Interlocal Agreement with Tarrant County.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, the City Council of the City of Keller, Texas hereby approves an Interlocal Agreement with Tarrant County for the rehabilitation and resurfacing of Bear Creek Parkway from Whitley Road to Rufe Snow

Drive, and Spring Branch Drive from Oak Valley Drive to Cul de Sac, for the Public Works Department, attached hereto as Exhibit "A"; and further authorizes the City Manager to execute said Agreement on behalf of the City of Keller, Texas.

Section 3:

THAT, the cost of said Project by Tarrant County shall be paid from the Street System Capital Improvements Project Fund with funding provided by the General Fund, in the amount of the actual costs for materials and equipment rental which has been estimated to cost \$704,622.78, budgeted therefor.
