RESOLUTION NO. 4472

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, CALLING THE GENERAL ELECTION FOR CITY COUNCIL PLACE 3 AND CITY COUNCIL PLACE 4 FOR THE CITY OF KELLER, TO BE HELD ON MAY 7, 2022, AS SET FORTH BY THE CHARTER AND BY THE TEXAS ELECTION CODE.

WHEREAS, the General Election for City Council Place 3 and City Council Place 4 for the City of Keller, as set forth by the Charter and by the Texas Election Code, is required to be held on May 7, 2022, at which time the voters will elect persons to fill the offices of City Council Place 3 and City Council Place 4.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: **Election Ordered**.

- (a) An election shall be held in the City of Keller, Texas on May 7, 2022, to elect persons to fill the offices of City Council Place 3 and City Council Place 4, to serve until May, 2025, or until their successors are duly elected and qualified.
- (b) Said election shall be held by Tarrant County pursuant to a Joint Election Agreement and Contract for Election Services, with respect to such General Election approved by the City Council of the City of Keller, Texas and Tarrant County Elections Administrator.

Section 3: **Election Day Voting Centers and Election Hours.** The registered voters in the City of Keller will be eligible to vote at Keller Town Hall, 1100 Bear Creek Parkway, Keller, Texas 76248 and any Tarrant County voting center, and pursuant to the Joint Election Agreement and Contract for Election Services with Tarrant County.

Voting shall be conducted between the hours of 7:00 a.m. and 7:00 p.m. on Saturday, May 7, 2022. Any run-off necessitated by the General Election will be held on Saturday, June 18, 2022 or as designated by the Joint Election Agreement and Contract for Election Services with Tarrant County, in accordance with the Texas Election Code.

Section 4: Filing for a Place on the Ballot. Qualified persons may file as candidates by filing an application in the office of the City Secretary, Monday through Friday, from 8:00 a.m. until 5:00 p.m., beginning Wednesday, January 19, 2022 and continue through Friday, February 18, 2022.

Section 5: **Election Officers**. The election officers for each polling place shall be appointed and compensated pursuant to the Joint Election Agreement and Contract for Election Services with Tarrant County, for said Election on May 7, 2022.

Section 6: a. Early voting by personal appearance.

Early voting by personal appearance shall be conducted at the Main Early Voting Location: Tarrant County Election Center, 2700 Premier Street, Fort Worth, Texas 76111, and at Keller Town Hall, 1100 Bear Creek Parkway, Keller, Texas 76248. All registered voters in the City of Keller will be able to vote at any Tarrant County early voting location, pursuant to the Joint Election Agreement and Contract for Election Services with Tarrant County. Early voting by personal appearance begins on Monday, April 25, 2022 and ends on Tuesday, May 3, 2022 during the hours listed below:

April 25-29, 2022 Monday-Friday 8:00 a.m. to 5:00 p.m.

April 30, 2022 Saturday 7:00 a.m. to 7:00 p.m.

May 1, 2022 Sunday 11:00 a.m. to 4:00 p.m.

May 2-3, 2022 Monday- Tuesday 7:00 a.m. – 7:00 p.m.

b. **Early voting by mail**. Tarrant County Elections Administrator, 2700 Premier Street, Fort Worth, Texas 76111 is hereby appointed as Early Voting Clerk. Applications for a Ballot by Mail must be submitted before the close of business on Tuesday, April 26, 2022 by mail, fax, or e-mail to:

c. Early voting ballot board. The Early Voting Ballot Board shall be appointed and designated in accordance with the provisions of the Joint Election Agreement and Contract for Election Services with Tarrant County.

Section 7: **Method of Voting**. Tarrant County's voting equipment will be utilized for said election, and shall be conducted in accordance with the Texas Election Code.

Section 8: **Governing Law**. The election shall be held as set forth by the Charter and the Texas Election Code, and all resident registered voters of the City shall be eligible to vote in said Election.

Section 9: **Effective Date.** This resolution shall be effective upon its adoption.
