## **RESOLUTION NO. 4661**

A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF KELLER, TEXAS, APPROVING A SITE PLAN AMENDMENT WITH A VARIANCE FOR DESI ADDA, IN AN EXISTING 7,100 SQUARE-FOOT BUILDING, SITUATED ON 1.25 ACRES LOCATED ON THE SOUTH SIDE OF KELLER PARKWAY, APPROXIMATELY 160 FEET EAST OF THE INTERSECTION OF KELLER PARKWAY AND TOWN CENTER LANE, LEGALLY DESCRIBED AS LOT 3, BLOCK B OF KELLER TOWN CENTER ADDITION, ZONED TOWN CENTER (TC) AND ADDRESSED 1110 KELLER PARKWAY, IN THE CITY OF KELLER, TARRANT COUNTY, TEXAS.

- WHEREAS, VC Keller Parkway LLC, Owner, and Ramesh Tinnanooru, Applicant, submitted a Site Plan Amendment application with a variance (SP-23-0005); and
- WHEREAS, the Applicant proposes to open a market and eatery in an existing 7,100 square-foot building located at 1110 Rufe Snow Drive; and
- WHEREAS, one variance is requested to allow the 43 parking spaces on-site plus 5 spaces via a shared parking agreement to fulfill the parking requirement of 48 spaces; and
- WHEREAS, the Site Plan Amendment, even with variances, does not require public hearings per the Unified Development Code (UDC); and
- WHEREAS, the Planning and Zoning Commission considered the proposed Site Plan Amendment with variances on April 25, 2023 and unanimously recommended approval of the item; and
- WHEREAS, the City Council does find that the request, with the added condition, meets the intent of the Unified Development Code (UDC);

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, a Site Plan Amendment with one variance for Desi Adda, in an existing 7,100 square-foot building, situated on 1.25 acres located on the south side of Keller Parkway, approximately 160 feet east of the intersection of Keller Parkway and Town Center Lane, legally described as Lot 3, Block B of Keller Town Center Addition, zoned Town Center (TC) and addressed 1110 Keller Parkway, is approved with the following variance:
