# Keller Pedestrian Facilities Master Plan Project Overview

## 2 Parts: ADA Transition Plan & School Pedestrian Route Plan

- Update of the City's Americans with Disabilities Act (ADA) Transition Plan
  - Evaluation of existing pedestrian facilities
  - Inventory of compliance needs
  - Includes public outreach, an implementation schedule and progress tracker
- Develop a School Pedestrian Route Plan
  - Identify primary walking routes to each of the eleven KISD schools
  - Evaluate pedestrian access to each of the eleven KISD schools
  - Develop an implementation of projects and estimated costs

# ADA Transition Plan

The Americans with Disabilities Act (ADA) became law on July 26, 1990

Applies to agencies with >50 employees (entire agency)

Requires public input

## Content

List of the physical barriers to the access of programs, activities, or services

Methods to remove the barriers

A schedule to get the work completed (with costs)

Specific responsible person(s) for the plan's implementation

Track status and record completion dates

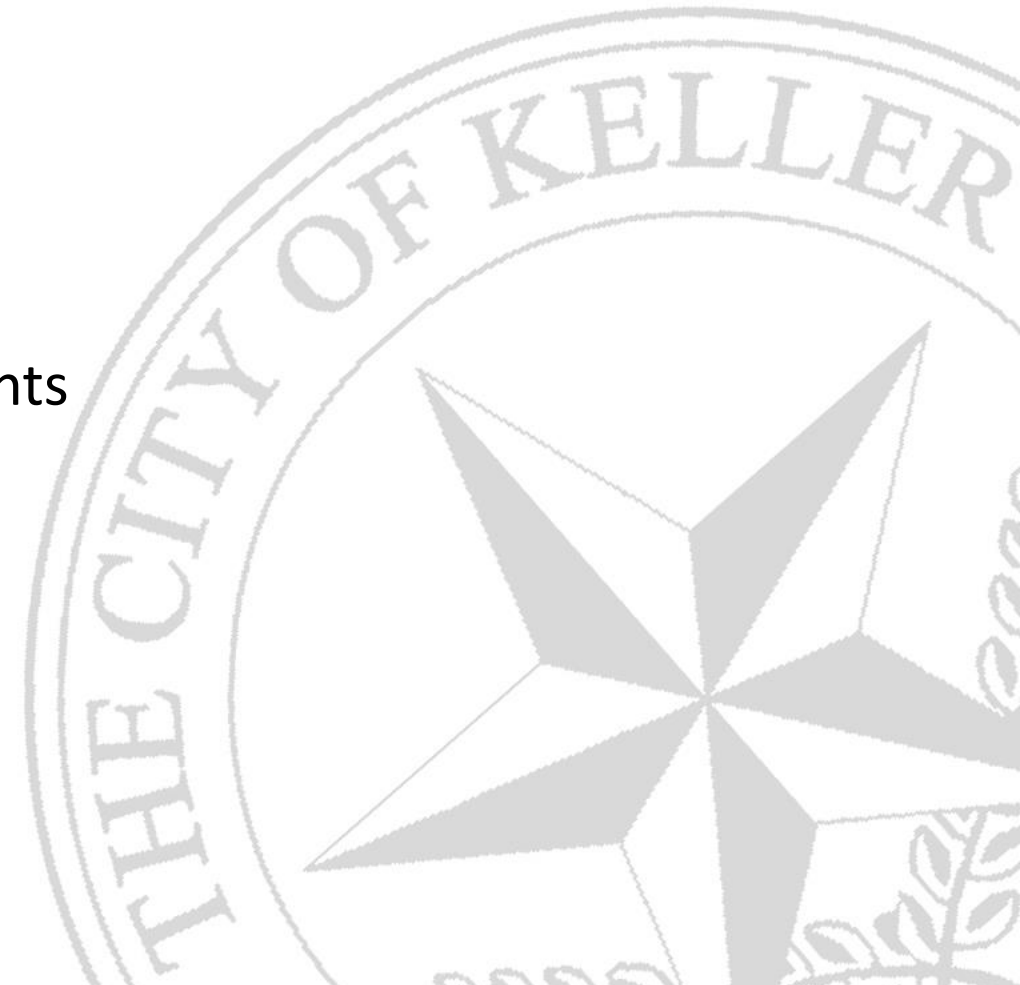
# Impacts of an ADA Transition Plan

## Future Grant Eligibility

- Stipulation of grant applications
- Required for fund allocation

## Federal / State Compliance

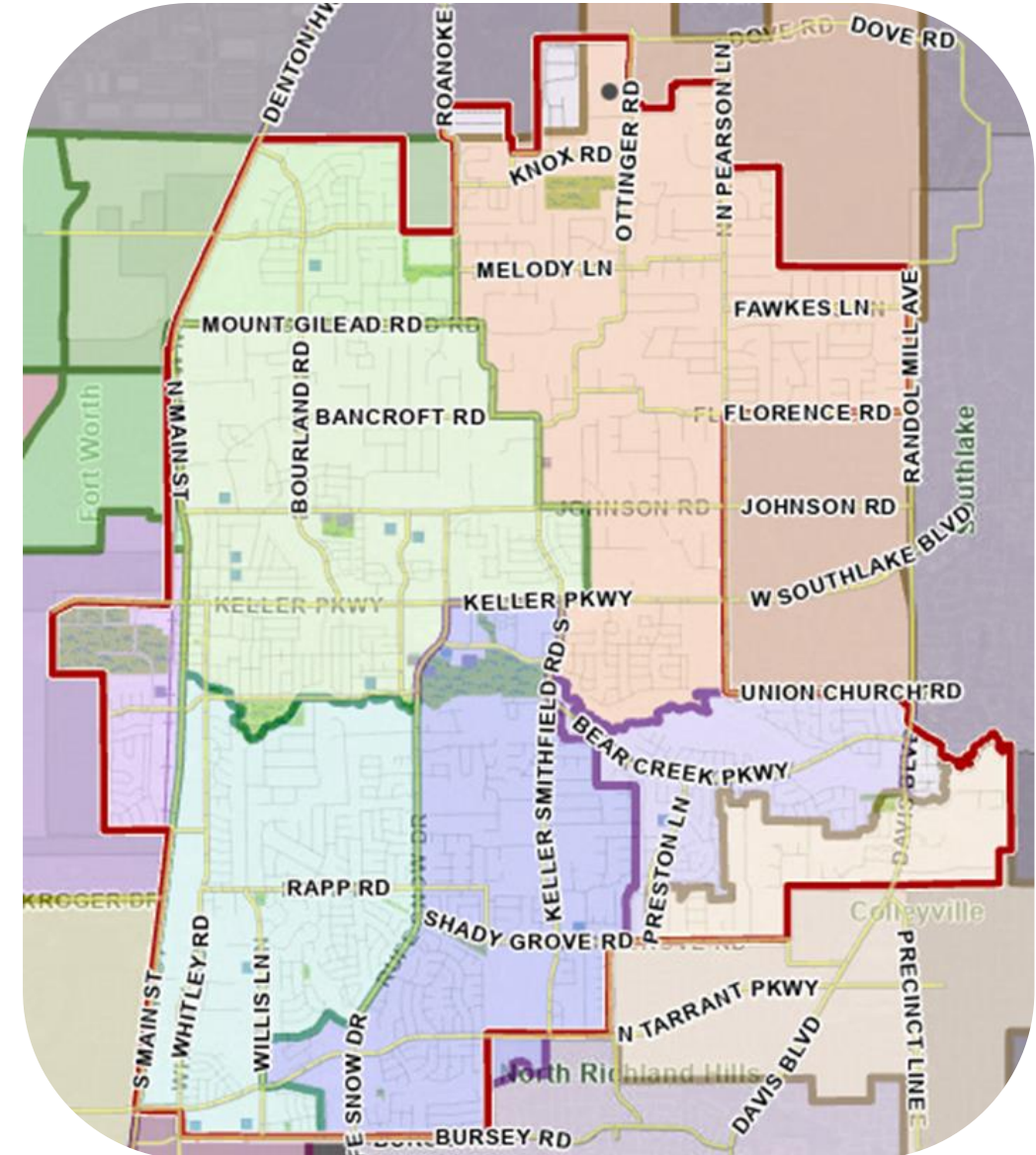
- Required of all of Federal or State fund recipients
- ADA Compliance Progress Reports
