

RESOLUTION NO. 4271

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, VOIDING THE AWARD OF THE BID FROM GI-MOW, OF NORTH RICHLAND HILLS, TEXAS, AND AWARDED THE NEXT LOWEST BID FROM EARTHWORKS, INC., OF ALVARADO, TEXAS, FOR CONTRACTUAL SERVICES RELATING TO KELLER SPORTS PARK GROUNDS MAINTENANCE SERVICES, FOR THE PARKS AND RECREATION DEPARTMENT, IN AN AMOUNT NOT TO EXCEED \$115,108.57, FOR THE REMAINING APPROXIMATELY ONE AND A HALF YEAR TERM; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, a request for sealed bids for Keller Sports Park Annual Grounds Maintenance Services for the Parks and Recreation Department was duly advertised in accordance with State law, and said bids were received, opened, and read aloud at 10:00 A.M., on Friday, December 28, 2018; and

WHEREAS, by Resolution No. 4089, dated February 5, 2019, the bid was awarded to GI-Mow of North Richland Hills, Texas, in the total amount of \$170,604.00, for a three-year term; and

WHEREAS, GI-Mow continuously failed to meet the basic requirements of the contract, forcing the City of Keller to cancel the contract; and

WHEREAS, the City has the option to award the contract to the next lowest bid; and

WHEREAS, the next lowest bid was received from Earthworks, Inc., of Alvarado, Texas, in the amount of \$80,576.00 for each one year term, totaling \$115,108.57 for the remaining approximately one and a half year term of said contract; and

WHEREAS, the three (3) sealed bids received have been reviewed by the Community Services Director, and it is determined that the bid received from Earthworks, Inc., of Alvarado, Texas, in the total amount of \$115,108.57 for the remaining approximately one and a half year term of the contract, is the next lowest and most responsible bid.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby voids the bid from GI-Mow, of North Richland Hills, Texas, and approves the bid from Earthworks, Inc., of Alvarado, Texas, for contractual services relating to Keller Sports Park Grounds Maintenance Services, for the Parks and Recreation Department, in an amount not to exceed \$80,576.00 per year and \$115,108.57 for the remaining approximately one and a half year term; and further authorizes the City Manager to execute all contract documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said Keller Sports Park Annual Grounds Maintenance Service is allocated from the General Fund/Parks and Recreation Fund budgeted in the Fiscal Year 2019-20 Annual Budget.
