B. MINUTES

1. Consider the approval of the minutes of the regular meeting on April 19, 2021.

Mr. Bob Stephenson motioned to approve the minutes as presented. Mrs. Becky Haskin seconded, and the motion passed unanimously.

C. OLD BUSINESS

1. Consider a resolution amending the City of Keller Façade Improvement Grant Program Policy approved by Resolution No. 4037, on September 18, 2018, by amending the policy criteria and process of the Façade Improvement Grant Program.

Mrs. Mary Culver presented an update to the City of Keller Façade Improvement Matching Grant Policy for consideration. Changes to the policy include:

- -Reducing cost proposal requirement to one contractor.
- -Removing requirement for a cost proposal from a Keller business and including it as a consideration for approval and fund allocation.
- -Removing the matching component of the grant and including it as a consideration for approval and fund allocation.
- -Increasing the maximum grant award to \$10,000.
- -Reducing the permanent fixture of the improvements to 24 months.

- -Removing the requirement of contractor qualification forms for those already registered with the city.
- -Increasing eligible improvements to include landscaping and art.

Mr. Mike Mitchell motioned to approve the update to the Façade Improvement Matching Grant Policy as presented, Mr. Greg Kocian seconded and the motion passed unanimously.

D. ADMINISTRATIVE COMMENTS

1. Receive and Economic Development update.

Mrs. Mary Culver provided board members with an economic development update which included new business openings, business recruitment and retention efforts, business relocations and status updates on businesses and current commercial developments.
