RESOLUTION NO. 4477

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING AN AGREEMENT WITH DATAVOX, OF HOUSTON, TEXAS, FOR THE PURCHASE, PROGRAMMING, AND INSTALLATION OF BUILDING SECURITY AND ACCESS CONTROL EQUIPMENT AND SOFTWARE FOR THE POLICE DEPARTMENT (POLICE STATION AND CAMPUS, EXCEPT DETENTION CENTER), THROUGH THE STATE OF TEXAS DEPARTMENT OF INFORMATION RESOURCES (DIR) COOPERATIVE PURCHASING PROGRAM, IN A TOTAL AMOUNT OF \$157,675; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

- WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to upgrade the Police Department's Access Control System (Police Station and campus, except detention center); and
- WHEREAS, the Fiscal Year 2021-22 Keller Crime Control and Prevention District Annual Budget provided for the purchase of said Security and Access Control services; and
- WHEREAS, the estimated cost of the project is \$157,675 which includes the initial contract costs of \$133,109.14 and contingency of \$24,565.86 due to the age of the infrastructure; and
- WHEREAS, the purchase of said building security and access control upgrades from Datavox, of Houston, Texas, through the State of Texas Department of Information Resources (DIR) Cooperative Purchasing Program, has been determined to be the best value and most responsible method of purchasing therefor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves the agreement with Datavox, of Houston, TX, for the purchase, programming, and installation of building security and access control equipment and software for the Police Department (Police Station and campus, except detention center, in the amount of \$157,675, through the State of Texas Department of Information Resources (DIR) Cooperative Purchasing Program, for the Information Technology Department; and further authorizes the City Manager to execute all

Section 3:	THAT, the cost of said purchase of building security and access control upgrades for the Police Department, shall be paid from the Keller Crime Control and Prevention Fund, budgeted therefor.
