A RESOLUTION OF THE CITY COUNCIL APPROVING AN AGREEMENT FOR MOBILE APP SERVICES WITH GOGOV, INC, OF ISLANDIA, NEW YORK, FOR THE PURPOSE OF DEVELOPING AND HOSTING A CUSTOMIZED MUNICIPALITY MOBILE APP FOR CITY OF KELLER, FOR A THREE (3) YEAR PERIOD WITH AN OPTION FOR TWO (2) ADDITIONAL ONE (1) YEAR EXTENSIONS; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS,

a Request for Proposals (RFP) for a Citizen Reporting and Engagement Tool for the Administration Department was duly advertised in accordance with State law, and said proposals were received by 2:00 P.M. on April 25, 2024; and

WHEREAS.

the eight qualified Request for Proposals (RFP) submissions that meet specifications have been reviewed, and it is determined that the proposal from GOGov, of Islandia, New York, in the annual amount of \$31,380, for a three year period, with the option to renew for two additional one-year periods, for a total of \$156,900 for five years, provides the best value for delivering a fully integrated citizen reporting solution and information portal providing mobile application, web platform, and texting capabilities; and

WHEREAS,

it is deemed to be in the best interest of the citizens of the City of Keller, Texas, and to further meet the obligations of the City, that the Proposal for a customized municipality mobile app with GOGov, Inc., of Islandia, New York, attached hereto as Exhibit "A," be hereby approved;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2:

THAT, the City Council of the City of Keller, Texas hereby approves the proposal for a customized municipality mobile app with GOGov, Inc., of Islandia, New York, for the purpose of delivering a fully integrated citizen reporting solution and information portal providing mobile application, web platform, and texting capabilities, for a three (3) year period with an option for two (2) additional one (1) year renewal periods, for a total of five (5) years; and further authorizes the City Manager to execute all contract documents on behalf of the City of Keller, Texas.
