## RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A CHAPTER 380 ECONOMIC DEVELOPMENT PROGRAM AGREEMENT, PURSUANT TO CHAPTER 380 OF THE TEXAS LOCAL GOVERNMENT CODE, AND PURSUANT TO THE CITY'S ECONOMIC DEVELOPMENT POLICY, WITH PK KELLER, LLC, FRANCHISE OWNER OF AN APPROXIMATELY 44,000 SF INDOOR RECREATIONAL PICKLEBALL FACILITY TO BE LOCATED AT 957 KELLER PARKWAY ON 4.02 ACRES KNOWN AS LOT 3R-1R4 & LOT 3R-1R3, BLOCK 8, BLUEBONNET TRAILS, KELLER, TEXAS; AND AUTHORIZING THE CITY MANAGER TO EXECUTE SAID DOCUMENTS ON BEHALF OF THE CITY OF KELLER, TEXAS.

- WHEREAS, PK KELLER, LLC (the "GRANTEE") by entering into this Chapter 380 Agreement (the "Agreement"), pursuant to Chapter 380 of the Texas Local Government Code, desires to construct and operate a forty-four thousand square foot indoor recreational pickleball facility at 957 Keller Parkway on 4.02 acres known as Lot 3R-1R4 & Lot 3R-1R3, Block 8, Bluebonnet Trails, Keller, Texas (the "Property"); and
- WHEREAS, Chapter 380 of the Texas Local Government Code provides that Texas municipalities may create programs to promote local economic development; and
- WHEREAS, pursuant to Chapter 380 of the Texas Local Government Code, the City has created a program called the City's Incentives Policy (the "Policy"); and
- WHEREAS, the City wishes to provide certain economic incentives to the Grantee and to assist in the development of Property; and
- WHEREAS, the City has concluded and hereby finds that the Agreement attached hereto as Exhibit "A", clearly promotes economic development in the City and, as such, meets the requisites under Chapter 380 of the Texas Local Government Code, the Policy; and further, it is in the best interest of the City; and
- WHEREAS, the Grantee has applied to the City for economic incentives, including those which are described in the Agreement; and
- WHEREAS, the Grantee understands and agrees that: (a) in granting renewing or extending any economic incentives, the City is relying upon Grantee's representations, warranties, and agreements, as set forth and provided for in the Agreement; (b) renewing or extending of any economic incentive by the City at all times shall be subject to the City's sole judgment and discretion; and (c) any such economic incentive shall be

and shall remain subject to the following terms and conditions of the Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2:

THAT, the City Council of the City of Keller, Texas, hereby approves a Chapter 380 Economic Development Program Agreement, attached hereto as Exhibit "A", pursuant to Chapter 380 of the Texas Local Government Code, and pursuant to the City's Economic Development Policy, with PK KELLER, LLC, a forty-four thousand square foot indoor recreational pickleball facility at 957 Keller Parkway on 4.02 acres known as Lot 3R-1R4 & Lot 3R-1R3, Block 8, Bluebonnet Trails, Keller, Texas; and further authorizes the City Manager to execute said documents on behalf of the City of Keller, Texas.
