

RESOLUTION NO. ____

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE BID FROM SRH LANDSCAPES, LLC., OF DALLAS, TEXAS, FOR CONTRACTUAL SERVICES RELATING TO KELLER TOWN CENTER LANDSCAPE MAINTENANCE SERVICES, FOR THE PARKS AND RECREATION DEPARTMENT, IN AN AMOUNT NOT TO EXCEED \$821,280.00, FOR A THREE-YEAR TERM; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, a request for sealed bids for Keller Town Center Annual Landscape Maintenance Services for the Parks and Recreation Department was duly advertised in accordance with State law, and said bids were received, opened, and read aloud at 10:00 a.m., on Wednesday, September 29, 2021; and

WHEREAS, the FY 2021-22 General Fund/Parks and Recreation Fund Budget provides for Keller Town Center Annual Landscape Maintenance Services for the Parks and Recreation Department; and

WHEREAS, the three (3) sealed bids received have been reviewed by the Community Services Director, and it is determined that the bid received from SRH Landscapes, LLC., of Dallas, Texas, in the total amount of \$821,280.00, for a three-year term, is the lowest and most responsible bid.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the bid from SRH Landscapes, LLC., of Dallas, Texas, for contractual services relating to Keller Town Center Landscape Maintenance Services, for the Parks and Recreation Department, in an amount not to exceed \$273,760.00 per year and \$821,280.00 for the three-year term; and further authorizes the City Manager to execute all contract documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said Keller Town Center Annual Landscape Maintenance Service is allocated from the General Fund/Parks and Recreation Fund in the FY 2021-22 Adopted Budget.
