A. CALL TO ORDER

Mayor Armin Mizani called the Special Meeting to Order at 11:03 A.M.

The following City Council Members were present: Mayor Armin Mizani, Council Member Shannon Dubberly, Council Member Greg Will, Council Member Karen Brennan, Council Member Tag Green, Council Member Chris Whatley, and Mayor Pro Tem Ross McMullin.

The following City staff members were present: City Manager Aaron Rector, City Attorney Stan Lowry, City Secretary Kelly Ballard, Director of Human Resources Marcia Reyna, and Fire Chief Bobby Tatum Jr.

B. EXECUTIVE SESSION

Mayor Armin Mizani recessed the Special City Council Meeting at 11:03 A.M. so that the City Council could meet in an Executive Session in accordance with State Law.
