RESOLUTION NO. 4677

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING AMENDMENT NO. 2 TO THE PROFESSIONAL SERVICES AGREEMENT WITH HR GREEN, OF PLANO, TEXAS, RELATING TO THE 2022 SIDEWALK REPAIR PROGRAM, FY2022-23 SIDEWALK REPAIR PROJECT, AND FY2023-24 SIDEWALK REPAIR PROJECT; AND AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENT NO. 1 RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

- WHEREAS, on August 16, 2022, the City of Keller, Texas entered into a professional services agreement with HR Green, of Plano, Texas for the 2022 Sidewalk Repair Program Project; and
- WHEREAS, further repair needs and activities were identified, necessitating the reprioritization of repair tasks, and schedule adjustments necessary to reduce costs and construction fatigue at the end of the project; and
- WHEREAS, Amendment No. 2, in the amount of \$217,000, will increase the total contract amount of \$345,000 by 62.9% to a new contract amount of \$562,000; and
- WHEREAS, Amendment No. 2, originally dated to expire on December 31, 2023, will further extend the contract expiration date to October 1, 2025.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, the City Council of the City of Keller, Texas hereby approves Amendment No. 2 to the professional services agreement with HR Green, of Plano, Texas, relating to the 2022 Sidewalk Repair Program, FY2022-23 Sidewalk Repair Project, and FY2023-24 Sidewalk Repair Project, in the total amount of \$217,000, in accordance with the terms and conditions set forth in said amendment No. 2, attached hereto as Exhibit "A"; and further authorizes the City Manager to execute said amendment No. 2 relating thereto on behalf of the City of Keller, Texas.
- Section 3: THAT, the cost of amendment No. 2 to the professional services agreement with HR Green, of Plano, Texas shall be paid from the Street System Capital Improvement Project Fund, with funding provided by the General Fund.

Section 4:	THAT, this resolution	n shall be	effective upon its adoption.
