1. Consider an update to the City of Keller Comprehensive Policy on Economic Development Incentives.

Mrs. Mary Culver presented an update to the City of Keller Comprehensive Policy on Economic Development Incentives which includes the addition of Equipment Purchase/Lease/Loan Guarantee, Sales, Lease or Exchange of land or buildings; Employment related incentives; and support for state and federal incentives. Updates to the policy includes the removal of the following: Neighborhood Empowerment Zones; Old Town Keller Façade Improvement Matching Grant; potential removal or update to Fast Track Permitting and the removal of language not recognized by the State of Texas regarding local incentives.

Mr. Bob Stephenson motioned to approve the update to the City of Keller Comprehensive Policy on Economic Development Incentives with the following amendments: the addition of clarifying verbiage to sections 1.2 and 1.4; removal of 1.3; addition of a clarifying statement in 5.9; the inclusion of the Economic Development Board in the application review process in 7.6.1; and clarifying verbiage to 7.6.2. Councilwoman Sheri Almond seconded and the motion passed unanimously.

Mrs. Mary Culver provided board members with an economic development update and review of new businesses opened and commercial activity through the 2021 calendar year. An update on business recruitment and retention efforts, and status updates were also provided.
