ORDINANCE NO. 1968

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A SPECIFIC USE PERMIT (SUP) FOR A SINGLE-STORY LIQUOR STORE (10,000 SF OR GREATER), ON APPROXIMATELY 1.712-ACRE PROPERTY, LOCATED ON THE EAST SIDE OF KELLER SMITHFIELD RD, APPROXIMATELY 425-FEET NORTHEAST OF THE INTERSECTION OF KELLER PARKWAY AND KELLER SMITHFIELD ROAD, BEING A PORTION OF TRACT 3A12, ABSTRACT 424, DUNHAM, J A SURVEY, ZONED TOWN CENTER (TC), AND ADDRESSED AS 100 CHANDLER ROAD (ACCOUNT#:03853381) IN THE CITY OF KELLER, TARRANT COUNTY, TEXAS; PROVIDING A PENALTY; AND AUTHORIZING PUBLICATION.

- WHEREAS, Greenway Keller, LP, Owner and McClure Partners, Applicant/Developer, have submitted an application to the City of Keller to construct a 12,180 square-foot, single-story Spec's retail liquor store; and
- WHEREAS, a Specific Use Permit is required to construct only a single-story (rather than a two-story) retail store in the Town Center Zoning District; and
- WHEREAS, a Specific Use Permit is required for any liquor store in the Town Center Zoning District (liquor stores less than 10,000 square-feet are not permitted in Town Center); and
- WHEREAS, notice of a public hearing before the Planning and Zoning Commission was sent to real property owners within three hundred-feet (300') of the property herein described at least ten (10) days before such hearing; and
- WHEREAS, Staff received two Keller citizen's emails in support and one Keller citizen's email in opposition; and
- WHEREAS, Staff received opposition from 21.27% within the 200-foot buffer regarding the SUP request; and
- WHEREAS, a super-majority vote is required per State Law when 20% or greater is within the 200-foot buffer; and
- WHEREAS, at the April 14, 2020, Planning and Zoning Commission meeting, the Commission held a public hearing and recommended unanimously to City Council to approve the two SUP requests; and
- WHEREAS, notice of a public hearing before the City Council was published in a newspaper of general circulation in Keller at least fifteen (15) days before such hearing; and

WHEREAS, City Council discussion was held with the Applicant to locate the screening wall and additional live-screening adjacent to the residence; and

WHEREAS, a public hearing to issue Specific Use Permits was held at the City Council meeting on April 14, 2020, and approved by a vote of 6-1; and

WHEREAS, the City Council finds that the Specific Use Permits further the purpose of zoning as set forth in the Unified Development Code;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, in accordance with the Unified Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of Specific Use Permits (SUPs) for a single-story liquor store (10,000 SF or greater), located on approximately 1.712-acre property, located on the east side of Keller Smithfield Rd, approximately 425-feet northeast of the intersection of Keller Parkway and Keller Smithfield Road, being a portion of Tract 3A12, Abstract 424, Dunham, J A Survey, zoned Town Center addressed Chandler (TC), and as 100 (Account#:03853381) in the City of Keller, Tarrant County, Texas, and incorporated herein, as if fully set forth.

Section 3: THAT, any person, firm, or corporation violating any of the provisions of this Ordinance, as read together with the Unified Development Code and accompanying map thereto, shall be guilty of a misdemeanor and upon final conviction therefore shall be fined in a sum not to exceed Two Thousand Dollars (\$2,000.00). Each and every day such violation continues shall constitute a separate offense and shall be punishable as such hereunder.

Section 4: THAT, the City Secretary is hereby authorized and directed to cause publication of the descriptive caption and penalty clause hereof as an alternative method of publication provided by law.
