RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE CITY OF KELLER'S COST PARTICIPATION IN THE PURCHASE OF A LENCO BEARCAT SWAT VEHICLE THROUGH THE NORTH TEXAS REGIONAL SWAT INTERLOCAL AGREEMENT; AUTHORIZING PAYMENT TO THE CITY OF ROANOKE FOR KELLER'S SHARE; CONFIRMING LENCO AS A SOLE SOURCE PROVIDER; AND PROVIDING AN EFFECTIVE DATE.

- WHEREAS, the City of Keller is a participant in the North Texas Regional SWAT Team through an interlocal agreement (Contract No. 15-180) with the cities of Roanoke, Southlake, Colleyville, and Trophy Club; and
- WHEREAS, the regional SWAT team leadership has jointly recommended the acquisition of a Lenco BearCat armored vehicle, a purpose-built tactical vehicle widely used in law enforcement operations; and
- WHEREAS, Lenco Industries, Inc. is the sole source manufacturer and distributor of the BearCat armored vehicle, as confirmed in a Sole Source Letter dated October 16, 2023; and
- WHEREAS, the City of Roanoke is facilitating the purchase of the vehicle on behalf of the regional SWAT team, with each member agency contributing its proportionate share of the total cost; and
- WHEREAS, the City of Keller's share of the cost is \$77,373.20, which was approved and appropriated as part of the City's FY 2024-25 Crime Control and Prevention District (CCPD) budget in the amount of \$80,469.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, City Council hereby authorizes the payment of \$77,373.20 to the City of Roanoke as the City of Keller's cost share for the purchase of a Lenco BearCat armored vehicle, as permitted under the North Texas Regional SWAT Interlocal Agreement.
- Section 2: THAT, City Council finds that Lenco Industries, Inc. is the sole source provider of the BearCat armored vehicle and that this purchase complies with the applicable procurement requirements under Texas law.
- Section 3: THAT, the City Manager is authorized to take all actions necessary to facilitate this transaction in accordance with the existing North Texas Regional SWAT Interlocal Agreement.
