## **RESOLUTION NO. 4503**

A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF KELLER, TEXAS, APPROVING THE PROPOSAL FROM BEARFOOT COMPANIES, LLC., OF CORINTH, TEXAS, FOR THE PURCHASE OF OUTDOOR POOL SEASONAL LIFEGUARD SERVICES, FOR THE KELLER POINTE RECREATION AND AQUATIC CENTER, IN THE TOTAL AMOUNT OF \$137,442.00; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS ON BEHALF OF THE CITY OF KELLER, TEXAS.

- WHEREAS, the City Council of the City of Keller, Texas has deemed it necessary and in the best interest of the citizens of the City of Keller to provide outdoor pool seasonal lifeguard services at The Keller Pointe Recreation and Aquatic Center; and
- WHEREAS, a request for sealed proposals for outdoor pool seasonal lifeguard services for The Keller Pointe Recreation and Aquatic Center was duly advertised in accordance with state law, and said proposals were received, opened, and read aloud at 2:00 P.M. on March 22, 2022; and
- WHEREAS, the one (1) proposal received has been reviewed by the Community Services Director, and it is determined that the proposal from Bearfoot Companies, LLC., of Corinth, Texas, in a total amount of \$137,442.00, is the lowest and most responsible proposal; and
- WHEREAS, the Fiscal Year 2021-2022 Annual Budget provides for the purchase of outdoor pool seasonal lifeguard services for The Keller Pointe Recreation and Aquatic Center; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the bid from Bearfoot Companies LLC., of Corinth, Texas, in the total amount of \$137,442.00 for the purchase of outdoor pool seasonal lifeguard services for The Keller Pointe Recreation and Aquatic Center; and further authorizes the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.
- Section 3: THAT, the cost of said outdoor pool seasonal lifeguard services for The Keller Pointe Recreation and Aquatic Center in the amount of
